SYNOPSIS:

This bill makes an appropriation of \$1,176,157 from the Education Trust Fund to Talladega College in Talladega, Alabama for the support and maintenance of the educational program of the institution, for the fiscal year ending September 30, 2025; provides that the appropriation is subject to certain provisions of the Code of Alabama 1975; requires an operations plan and an audited financial statement prior to the release of any funds; and requires an end of year report.

A BILL
TO BE ENTITLED
AN ACT

To make an appropriation of \$1,176,157 from the Education Trust Fund to Talladega College in Talladega, Alabama for the support and maintenance of the educational program of the institution, for the fiscal year ending September 30, 2025; to provide that the appropriation is subject to certain provisions of the Code of Alabama 1975; to require an operations plan and an audited financial statement prior to the release of any funds; and to require an end of year report.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

HB149 INTRODUCED

29 Section 1. There is hereby appropriated the sum of
30 \$1,176,157 from the Education Trust Fund to Talladega College
31 in Talladega, Alabama for the support and maintenance of the
32 educational program of the institution, for the fiscal year
33 ending September 30, 2025.

34 Section 2. The above appropriation is made for the
35 support of public education in Alabama and for the support and
36 maintenance of the above program. The appropriation shall be
37 subject to the provisions, terms, conditions, and limitations
38 of the Budget and Financial Control Act, Code of Alabama 1975,
39 Sections 41-4-80 et seq.; the provisions of the Budget
40 Management Act of 1976, Code of Alabama 1975, Sections 41-19-1
41 et seq.; and any other provisions of this act.

42 Section 3. (a) Prior to the release of any funds
43 appropriated under this act the following reports shall be
44 submitted:

45 (1) An operations plan for the fiscal year 2025,
46 including goals and measurable performance indicators, shall
47 be submitted to and approved by the Director of Finance, as
48 provided for state agencies in Code of Alabama 1975, Section
49 41-19-10.

50 (2) An audited financial statement for all operations
51 during the fiscal year 2023.

52 (b) It is the intent that funds appropriated for fiscal
53 year 2025 shall be released by the Director of Finance
54 following receipt of the above reports.

55 (c) In addition, quarterly reports shall be made to the
56 Director of Finance relating actual expenditures and

57 accomplishments to planned expenditures and accomplishments.
58 An end of year performance report for the fiscal year 2025
59 shall be made to the Director of Finance stating the work
60 accomplished and the services provided and the costs of
61 accomplishing the work and providing the services, citing
62 meaningful measures of program effectiveness and costs, as is
63 required for state agencies in Code of Alabama 1975, Section
64 41-19-11.

65 (d) The Director of Finance shall forward a copy of all
66 required reports to the Legislative Council in a timely
67 manner.

68 Section 4. This act shall become effective October 1,
69 2024.
