4 SYNOPSIS:

Under existing law, fire-protection personnel undergo training prior to permanent employment.

This bill would require that pre-employment training for fire-protection personnel include training on interacting with individuals with sensory needs or invisible disabilities.

Under existing law, certified volunteer firefighters undergo training prior to certification.

This bill would require pre-certification training for volunteer firefighters to include training on interacting with individuals with sensory needs or invisible disabilities.

This bill would require each fire-protection personnel and certified volunteer firefighter to undergo annual training on interacting with individuals with sensory needs or invisible disabilities.

This bill would exclude non-certified volunteer firefighters and employees of the Alabama State

Forestry Commission from training requirements related to interacting with individuals with sensory needs or invisible disabilities.

This bill would allow non-certified volunteer firefighters to voluntarily undergo training about interacting with individuals with sensory needs or

53	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
54	Section 1. This act shall be known and may be cited as
55	the Abram Colin Act.
56	Section 2. Section 36-32-7, Code of Alabama 1975, is



57 amended to read as follows:

**"**\$36-32-7

- (a) Applicability. The minimum standards provided in this section shall apply to trainees who are to be employed as fire-protection personnel by a public fire-fighting agency.

  NoA city or fire-fighting agency—which that provides fire protection to the public—shall may not permanently employ any trainee as fire-protection personnel who has not met the requirements of this section. Provided, however, no A fire prevention inspector, fire protection engineer, public fire and life safety educator, public safety dispatcher, or person\_individual whose duties are solely clerical or secretarial in nature employed as fire-protection personnel by the fire-fighting agency of any Class 1 municipality shall be is not required to meet the minimum physical requirements as a trainee for firefighter as prescribed by the commission.
  - (b) Employment and qualifications. The trainee shallmust be certified by a licensed practicing physician as satisfactory by the appointing authority designated as being in good health and physically fit for the performance of his or her duties as a firefighter and shallmust meet the employment qualifications of the appointing authority.
- (c) Training.
  - (1) FIRE-PROTECTION PERSONNEL. Prior to permanent employment, or a period not exceeding 12 months after the date of employment, the trainee shall have met must meet the requirements for certification as prescribed by the commission. Training shall be given by an instructor certified



by the Alabama Firefighters' Personnel Standards and Education Commission and the training may be administered within the department in which the applicant seeks to serve, if the department meets the requirements of the commission for a training center. Upon the completion of training, the commission shall administer a comprehensive written test to each applicant;, and each applicant must pass the test as a condition of completion of such the training.

- (2) VOLUNTEER FIREFIGHTER. A volunteer firefighter may be certified by the commission as a volunteer firefighter if the volunteer firefighter shall have has met the training requirements prescribed by the commission. Provided, the The training is must be conducted by an instructor certified by and in facilities approved by the commission. The training need not be during continuous sessions but may be scheduled at different intervals during a period not exceeding 24 months for a total of 160 hours. This subdivision shall not be construed as to mandate training for volunteer firefighters, except for purposes of certification.
- (d) (1) Beginning January 1, 2025, the Alabama

  Firefighters' Personnel Standards and Education Commission shall require both of the following:
- a. The training required by subsection (c) for volunteer firefighters seeking certification and fire protection personnel must include at least one hour of training on interacting with individuals with sensory needs or invisible disabilities.
  - b. That each fire-protection personnel and certified
