7 WHEREAS, it is with the highest accolade that this
8 body honors the memory of William Howell "Skip" Rogers, Sr.
9 by requesting the Department of Transportation designate the
10 portion of Alabama State Highway Route 157 between mile
11 markers 40 and 41 in Lawrence County, Alabama, as the
12 William Howell Rogers, Sr. Memorial Mile; and

13 WHEREAS, Mr. Rogers was a Veteran of the Korean
14 Conflict, having served in the United States Air Force from
15 1951 to 1955; after completing his military service, he
16 continued to have the calling to serve others and earned a
17 Bachelor of Science in Commerce and Business Administration
18 followed by a Juris Doctor from The University of Alabama;

20 WHEREAS, Mr. Rogers established himself in the
21 practice of law working at Thiokol in Huntsville for several
22 years before beginning his private practice in Moulton,
23 Alabama; and

24 WHEREAS, Mr. Rogers served the City of Moulton for
25 more than 50 years as its City Attorney and as City Judge;

27 WHEREAS, Mr. Rogers was also a dedicated servant of
28 his Lord and Savior, Jesus Christ; he passed on March 24,

29 2020, but his legacy in Moulton lives on through his family,
30 friends, and the many good works he did during his lifetime;

32 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
33 HOUSES THEREOF CONCURRING, That to honor William Howell
34 "Skip" Rogers, Sr., the Department of Transportation is
35 encouraged to coordinate with local governing officials to
36 consider designating the portion of Alabama State Highway
37 Route 157 between mile markers 40 and 41 in Lawrence County,
38 Alabama, as the William Howell Rogers, Sr. Memorial Mile and
39 to erect appropriate signs or markers, consistent with
40 applicable requirements and laws, in recognition of this
41 designation.
