3 NAMING A PORTION OF ALABAMA STATE ROUTE 181 IN
4 BALDWIN COUNTY, ALABAMA, THE REPRESENTATIVE JOE FAUST
5 HIGHWAY.

7 WHEREAS, it is with the highest accolade that this
8 body honors the exemplary service and contributions of
9 former State Representative Joe Faust by requesting the
10 Department of Transportation designate Alabama State Route
11 181 from State Route 104 to County Road 32 in Baldwin
12 County, Alabama, as the Representative Joe Faust Highway;
13 and

14 WHEREAS, Representative Faust was born on September
15 13, 1940, in Birmingham, Alabama; he is a graduate of the
16 Marietta Johnson School of Organic Education in Fairhope,
17 Alabama, and attended Faulkner Community College where he
18 studied business; and

19 WHEREAS, Representative Faust served in the National
20 Guard from 1958-1966 and one year during the Berlin Crisis
21 in 1962; and

22 WHEREAS, Representative Faust has been a resident of
23 Baldwin County since 1942; he and his wife, Sharon, have
24 four children and seven grandchildren; and

25 WHEREAS, Representative Faust began his career as a
26 regional sales manager and later, supervisor in the retail
27 milk business; he also worked as an insurance broker; and

28 WHEREAS, Representative Faust was elected to the

29 Baldwin County Commission in 1996 and again in 2000; he
30 served as the Chairman of the Baldwin County Commission,
31 Vice Chairman of the Baldwin County Commission, is a board
32 member of the Marietta Johnson School of Organic Education,
33 former board member of the Eastern Shore Chamber of
34 Commerce, and a Mason; Representative Faust was elected in
35 2002 to serve as a House Representative for District 94; he
36 was elected for five terms; and

37 WHEREAS, it is fitting to honor Representative Faust
38 by naming this portion of highway in Baldwin County in
39 recognition of his service and leadership to the residents
40 of Alabama; now therefore,

41 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
42 HOUSES THEREOF CONCURRING, That to honor the many years of
43 public service of Representative Joe Faust, the Department
44 of Transportation is encouraged to coordinate with local
45 governing officials to consider designating the portion of
46 Alabama State Route 181 from State Route 104 to County Road
47 32 in Baldwin County, Alabama, as the Representative Joe
48 Faust Highway and to erect appropriate signs or markers,
49 consistent with applicable requirements and laws, in
50 recognition of this designation.
