22	Trooper Carlton that he would have to call for another
23	ambulance since there were already two patients who needed
24	immediate medical attention; Senior Trooper Carlton advised
25	Wicksburg Rescue that he would transport the child in his
26	patrol vehicle instead of waiting for another ambulance to
27	arrive: Senior Trooper Carlton, along with a private citize

30	WHEREAS, after arriving at the Flowers Hospital
31	Emergency Room, the hospital staff was able to assess the
32	child and get him stabilized; after speaking with physicians
33	and the hospital staff, Senior Trooper Carlton returned to
3 4	the lobby only to find that the nurse who assisted the child
35	during transport had left and could not be found; and
36	WHEREAS, the young child was later transported to
37	Sacred Heart Hospital in Pensacola, Florida, and is expected
38	to make a full recovery; Jessica Joy Thrasher was
39	transported to Southeast Health in Dothan and later UAB
40	Hospital in Birmingham; she has undergone numerous surgeries
41	and is expected to make a a full recovery; and
42	WHEREAS, the quick thinking efforts of Senior Trooper
43	Christopher Carlton and his decision to transport a small
4 4	child suffering from a serious head injury in his patrol
45	vehicle served a major role in saving that child's life; he
46	is truly deserving of special recognition; now therefore,
