4 SJR____ NAMING THE PORTION OF ALABAMA STATE HIGHWAY ROUTE 157
5 BETWEEN MILE MARKERS 40 AND 41 IN LAWRENCE COUNTY, ALABAMA,
6 THE WILLIAM HOWELL ROGERS, SR. MEMORIAL MILE.

8 WHEREAS, it is with the highest accolade that this
9 body honors the memory of William Howell "Skip" Rogers, Sr.
10 by requesting the Department of Transportation designate the
11 portion of Alabama State Highway Route 157 between mile
12 markers 40 and 41 in Lawrence County, Alabama, as the
13 William Howell Rogers, Sr. Memorial Mile; and

14 WHEREAS, Mr. Rogers was a Veteran of the Korean
15 Conflict, having served in the United States Air Force from
16 1951 to 1955; after completing his military service, he
17 continued to have the calling to serve others and earned a
18 Bachelor of Science in Commerce and Business Administration
19 followed by a Juris Doctor from The University of Alabama;
20 and

21 WHEREAS, Mr. Rogers established himself in the
22 practice of law working at Thiokol in Huntsville for several
23 years before beginning his private practice in Moulton,
24 Alabama; and

25 WHEREAS, Mr. Rogers served the City of Moulton for
26 more than 50 years as its City Attorney and as City Judge;

28 WHEREAS, Mr. Rogers was also a dedicated servant of

29 his Lord and Savior, Jesus Christ; he passed on March 24,
30 2020, but his legacy in Moulton lives on through his family,
31 friends, and the many good works he did during his lifetime;

33 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
34 HOUSES THEREOF CONCURRING, That to honor William Howell
35 "Skip" Rogers, Sr., the Department of Transportation is
36 encouraged to coordinate with local governing officials to
37 consider designating the portion of Alabama State Highway
38 Route 157 between mile markers 40 and 41 in Lawrence County,
39 Alabama, as the William Howell Rogers, Sr. Memorial Mile and
40 to erect appropriate signs or markers, consistent with
41 applicable requirements and laws, in recognition of this
42 designation.
