House Bill 106 as passed the House of Representatives could decrease receipts to the Education Trust Fund, beginning in Fiscal Year 2027, by an undetermined amount dependent upon the additional amounts contributed to catastrophe savings accounts due to the increased caps on contributions provided by this bill.
