5	Existing law establishes state holidays.
6	This bill would specify that the State of
7	Alabama shall observe as holidays all days designated
8	as a holiday by the federal government.
9	This bill would delete duplicative language and
10	would also make nonsubstantive, technical revisions to
11	update the existing code language to current style.

18	Relating to state holidays; to amend Section 1-3-8,
19	Code of Alabama 1975; to specify that the State of Alabama
20	shall observe as holidays all days designated as a holiday by
21	the federal government; and to delete duplicative language and
22	make nonsubstantive, technical revisions to update the
23	existing code language to current style.
24	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
25	Section 1. Section 1-3-8, Code of Alabama 1975, is
26	amended to read as follows:

28	(a) Sunday, Christmas Day, New Year's Day, Martin



29	Luther King, Jr.'s birthday, Robert E. Lee's birthday, George
30	Washington's birthday, Thomas Jefferson's birthday,
31	Confederate Memorial Day, National Memorial Day, Jefferson
32	Davis' birthday, the Fourth day of July, Labor Day, Columbus
33	Day and Fraternal Day, Veterans' Day, American Indian Heritage
34	Day, and the day designated by the Governor for public
35	thanksgiving shall each be deemed a holiday. If any holiday
36	falls on Sunday, the following day is the holiday. If any
37	holiday falls on Saturday, the preceding day is the holiday.
38	Veterans' Day shall be observed by the closing of all state,
39	county, and municipal offices, all banks located within this
40	state, and the public schools on such day. Public schools,

42	institutions of higher education shall also be closed on
43	National Memorial Day, and such closing shall be applicable to

61	(b) If any holiday falls on Sunday, the following day
62	is the holiday. If any holiday falls on Saturday, the
63	preceding day is the holiday.
64	(c) The Governor shall close all state offices and
65	facilities a minimum of 13 days throughout the year and not
66	more than 13 days in observance of the public and legal
67	holidays and other days set forth in subsection (a). The
68	Governor shall also specify the days state offices and
69	facilities shall be closed in observation of public and legal
70	holidays.
71	(d) The Superintendent of Banks, with the concurrence
72	of not less than two members of the state Banking Board, may
73	authorize any state bank to close on National Memorial Day,
74	the last Monday in May, the closure of state banks in
75	observance of any state or federal holiday and on such any
76	other <u>days</u> day as may be declared by the Governor to be \underline{a}

85	(b) Of the above enumerated legal public holidays, the
86	following shall be observed on the dates herein prescribed:
87	(1) Robert E. Lee's birthday - the third Monday in
88	January.
89	(2) George Washington's birthday - the third Monday in
90	February.
91	(3) Confederate Memorial Day - the fourth Monday in
92	April.
93	(4) Jefferson Davis' birthday - the first Monday in
94	June.
95	(5) Columbus Day and Fraternal Day - the second Monday
96	in October.
97	(6) Veterans' Day - the eleventh day of November.
98	(7) Martin Luther King, Jr.'s birthday - the third
99	Monday in January.
100	(8) National Memorial Day - the last Monday in May.
101	(9) Thomas Jefferson's birthday - the third Monday in
102	February.
103	(10) American Indian Heritage Day - the second Monday
104	in October.
105	(c)(1) In addition to the legal holidays provided
106	above in subsection (a), Mardi Gras shall be deemed a holiday
107	in Mobile and Baldwin Counties and all state offices shall be
108	closed in those counties on Mardi Gras.
109	(d)(2) All In addition to the legal holidays provided
110	above all state employees, except other than those employed in
111	Baldwin and Mobile Counties $_{m{ au}}$ shall be granted one personal
112	leave day per year. The personal leave day shall be granted on



113 January 1 of each year. All state employees employed in Baldwin and Mobile Counties shall be granted no personal leave 114 115 day. All such personal leave days granted in any year pursuant 116 to this section shall be used by the end of the calendar year. 117 All such personal leave days shall and must be scheduled during the year with the approval of the supervisor. 118 Supervisors failing to schedule personal leave days for 119 120 employees shall justify that action in writing to the Director 121 of State Personnel and the employee shall receive pay at a rate not less than the employee's usual and customary rate of 122 123 pay for any personal leave day not taken by December 31 of 124 each year.

125 (e) (f) (1) All state holidays shall be observed by the closing of all state offices. Any state office may remain open 126 127 on a state holiday upon written notice by the appointing 128 authority to the State Personnel Board at least 60 days in 129 advance of the holiday. Provided, that In addition, any state 130 office may be opened in the event of an emergency, and the 131 State Personnel Board may grant a blanket approval for the 132 openings opening of state offices needing to be open on 133 holidays on a regular basis for essential services.

134 (2) Any state employee working on a state holiday shall
135 receive a day of compensatory leave or paid compensation in
136 lieu of the holiday as provided herein.

137 (f) (g) Each employee shall attempt to schedule any 138 compensatory leave day provided in lieu of a regularly 139 scheduled holiday, subject to the approval of the his or her 140 supervisor, during the quarter that the regularly scheduled



141 holiday occurred. If any compensatory leave day cannot be 142 scheduled during the designated guarter, the compensatory 143 leave day may be accumulated at the request of the employee 144 for up to one year. Supervisors failing to schedule 145 compensatory leave days for employees within the quarter, 146 unless the day is carried forward at the request of the 147 employee, shall justify that action in writing to the Director 148 of State Personnel and the employee shall receive pay at a 149 rate not less than the employee's usual and customary rate of pay for any compensatory leave day to which the employee may 150 151 be entitled and which has not been taken.

152 (q) (1) (h) (1) The first day in December of each year is 153 designated as Mrs. Rosa L. Parks Day in this state. All 154 citizens of this state are requested to devote some portion of 155 Mrs. Rosa L. Parks Day to commemorate the accomplishments of 156 Mrs. Rosa L. Parks, a woman of great courage, vision, love, 157 and faith who helped usher in the modern civil rights movement 158 on December 1, 1955, by refusing to give up her seat on a bus 159 in Montgomery, Alabama. Each resident of this state is 160 requested to observe the day with appropriate activities.

161 (2) Each county and municipality may elect to observe162 Mrs. Rosa L. Parks Day as a holiday."

Section 2. This act shall become effective on October 164 1, 2025.
