- Relating to Choctaw County; to provide for the assessment of additional court costs in certain civil, criminal, or quasi-criminal proceedings in the circuit court and district court and in any municipal court in Choctaw County; to provide that the costs, upon collection, shall be distributed to a special fund, designated as the "Jail Fund," in the county treasury to be expended by the county for paying the costs of maintaining, repairing, and operating the county jail and jail complex and for paying any indebtedness incurred for the construction of the county jail and jail complex.
- Section 1. (a) In Choctaw County, in addition to any court costs authorized to be collected, there shall be assessed an additional court cost of fifty dollars (\$50) in all civil cases filed in the circuit court and district court, except in cases filed in the small claims court the additional court costs shall be twenty-five dollars (\$25).

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

- (b) In addition to any court costs authorized to be collected, there shall be assessed an additional court cost of fifty dollars (\$50) in all criminal and quasi-criminal cases brought in the circuit court and district court and in any municipal court in Choctaw County.
