14	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
15	Section 1. This act shall only apply in Elmore County.
16	Section 2. (a)(1) A court cost of one hundred dollars
17	(\$100) shall be assessed and collected in all cases processed
18	through the circuit court of the county, excluding traffic
19	cases.
20	(2) This fee shall increase by five dollars (\$5) on
21	January 1 each year.
22	(b)(1) This court cost shall be in addition to any
23	other court costs and fees.
24	(2) The court cost shall not be waived by any court
25	unless all other fees, assessments, costs, fines, and charges
26	associated with the case are waived.
27	(c)(1) The clerk of the court shall collect this court
28	cost as other costs of the court are assessed and collected.

- (2) a. The county commission shall appropriate the proceeds from the additional court cost for debt service of the expansion and renovation the judicial complex properties.
- b. Upon satisfaction of the debt service, the county commission shall appropriate the proceeds from the additional court cost for the maintenance, operations, and upgrade of the facilities located on the judicial complex parcel.
- Section 3. (a) (1) A booking fee of one hundred dollars (\$100) shall be assessed by the clerk of the court against each defendant incarcerated in or booked into the Elmore County Jail provided the defendant is convicted or pleads guilty in cases prosecuted in the circuit or district court of the county.
