5	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
6	Section 1. Section 45-50-230, Code of Alabama 1975, is
7	amended to read as follows:
8	" §45-50-230
9	(a) (1) In Monroe County, effective immediately, the
10	sheriff is entitled to receive an expense allowance in the
11	amount of ten thousand dollars (\$10,000) per annum. The
12	expense allowance shall be in addition to any and all other
13	compensation heretofore provided by law and shall be payable
14	from the county general fund.
15	(2) The expense allowance provided for by this
16	subsection shall be paid each month from the treasury of
17	Monroe County, in the same manner as county employees are
18	paid. The sheriff receiving this expense allowance shall not
19	be required to file an accounting thereof.
20	(3) Effective with the beginning of the next term of
21	office, the sheriff is hereby entitled to receive an
22	additional county salary in the amount of ten thousand dollar
23	(\$10,000) per annum and the provisions of subdivision (1), at
24	that time, shall become null and void. The county compensation
25	shall be paid out of the General Fund of Monroe County in the
26	same manner as other county employees.
27	(4) If there should be enacted a statewide law

providing for an increase in the sheriff's salary which, when

29 added to the increase provided for under this subsection shall exceed ten thousand dollars (\$10,000), then the amount of the 30 salary increase provided for under this subsection shall 31 32 decrease by the amount in excess of ten thousand dollars 33 (\$10,000). 34 (b) (1) The Sheriff of Monroe County shall receive 35 expense allowance of ten thousand dollars (\$10,000) per year, 36 payable in equal monthly installments from the general fund of 37 the county. This expense allowance shall be in addition to all other compensation or benefits received by the sheriff and may 38 be treated as compensation for retirement contributions. 39 (2) Beginning with the next term of office, the expense 40 41 allowance paid to the sheriff as provided in subdivision (1) shall become additional compensation for the sheriff and the 42 43 expense allowance shall be null and void. This compensation shall be in addition to all other compensation or benefits 44 45 received. 46 (c) (1) The Sheriff of Monroe County shall receive an 47 additional expense allowance of fifteen thousand dollars (\$15,000) per year, payable in equal monthly installments from 48 49 the general fund of the county. This expense allowance shall 50 be in addition to all other compensation or benefits received by the sheriff and may be treated as compensation for 51 52 retirement contributions. 53 (2) Beginning with the next term of office, the expense 54 allowance paid to the sheriff as provided in subdivision (1)

68	(c) Beginning January 18, 2027, the sheriff's base
69	salary authorized in subsection (a) shall be increased by
