5 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

6 Section 1. Section 45-50-230, Code of Alabama 1975, is
7 amended to read as follows:

8 "§45-50-230

9 ~~(a) (1) In Monroe County, effective immediately, the~~
10 ~~sheriff is entitled to receive an expense allowance in the~~
11 ~~amount of ten thousand dollars (\$10,000) per annum. The~~
12 ~~expense allowance shall be in addition to any and all other~~
13 ~~compensation heretofore provided by law and shall be payable~~
14 ~~from the county general fund.~~

15 ~~(2) The expense allowance provided for by this~~
16 ~~subsection shall be paid each month from the treasury of~~
17 ~~Monroe County, in the same manner as county employees are~~
18 ~~paid. The sheriff receiving this expense allowance shall not~~
19 ~~be required to file an accounting thereof.~~

20 ~~(3) Effective with the beginning of the next term of~~
21 ~~office, the sheriff is hereby entitled to receive an~~
22 ~~additional county salary in the amount of ten thousand dollars~~
23 ~~(\$10,000) per annum and the provisions of subdivision (1), at~~
24 ~~that time, shall become null and void. The county compensation~~
25 ~~shall be paid out of the General Fund of Monroe County in the~~
26 ~~same manner as other county employees.~~

27 ~~(4) If there should be enacted a statewide law~~

34 ~~(b) (1) The Sheriff of Monroe County shall receive an~~
35 ~~expense allowance of ten thousand dollars (\$10,000) per year,~~
36 ~~payable in equal monthly installments from the general fund of~~
37 ~~the county. This expense allowance shall be in addition to all~~
38 ~~other compensation or benefits received by the sheriff and may~~
39 ~~be treated as compensation for retirement contributions.~~

40 ~~(2) Beginning with the next term of office, the expense~~

59 (a) Until January 18, 2027, the Sheriff of Monroe
60 County shall continue to receive the same base annual salary
61 the sheriff is receiving on May 31, 2025.

62 (b) Beginning October 1, 2025, in addition to the base
63 salary authorized in subsection (a), the sheriff shall receive
64 an expense allowance of fifteen thousand dollars (\$15,000) per
65 annum, payable in equal monthly installments from the county
66 general fund. The expense allowance shall be treated as salary
67 for retirement purposes.

68 (c) Beginning January 18, 2027, the sheriff's base
69 salary authorized in subsection (a) shall be increased by
70 fifteen thousand dollars (\$15,000) per annum and the expense
71 allowance authorized in subsection (b) is repealed."

72 Section 2. This act shall become effective on June 1,
73 2025.
