21	Section 1. (a) Until January 18, 2027, the Sheriff of
22	Talladega County shall continue to receive the same base
23	annual salary the sheriff is receiving on May 31, 2025.
24	(b) Beginning June 1, 2025, in addition to the base
25	annual salary authorized in subsection (a), the sheriff shall
26	receive an expense allowance of fifteen thousand two hundred
27	dollars and thirty-two cents (\$15,200.32) per annum, payable
28	in equal monthly installments from the county general fund.

(c) Beginning January 18, 2027, the sheriff shall 29 30 receive a base annual salary of one hundred twelve thousand 31 dollars (\$112,000) per annum, payable in equal monthly 32 installments from the county general fund, and the salary and 33 expense allowance authorized in subsections (a) and (b) are 34 void. 35 Section 2.
