A BILL
TO BE ENTITLED
AN ACT

Relating to Madison County; to amend Section 45-45-230.01, Code of Alabama 1975, to further provide for the compensation of the sheriff.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 45-45-230.01, Code of Alabama 1975, is amended to read as follows:

"§45-45-230.01

~~(a) Commencing with the next term of office beginning in January of 1999, the Sheriff of Madison County shall receive an annual salary of seventy thousand dollars (\$70,000)~~Any newly-elected Sheriff of Madison County shall receive a base salary of one hundred seventy thousand dollars (\$170,000) per year, effective as of the first full pay period after the start of the newly-elected sheriff's first term in office, which begins on the first Monday after the second Tuesday of January next after the sheriff's election pursuant to Section 36-3-4.

(b) After serving a first full four-year term in office, if the sheriff is re-elected to a second successive term, the sheriff shall receive a 7.5 percent salary increase,

29 effective as of the first full pay period after the start of
30 the sheriff's second successive term, which begins on the
31 first Monday after the second Tuesday of January next after
32 the sheriff's selection pursuant to Section 36-3-4.

33 (c) After serving a second full four-year term in
34 office, if the sheriff is re-elected to any successive term,
35 then the sheriff shall receive an increase in the sheriff's
36 then-existing salary in the amount of 7.5 percent, effective
37 as of the first full pay period after the start of each
38 successive term, which begins on the first Monday after the
39 second Tuesday of January next after the sheriff's election
40 pursuant to Section 36-3-4.

41 (d) If the sheriff is elected to a non-successive term,
42 the sheriff shall receive a salary of one hundred seventy
43 thousand dollars (\$170,00) per year, effective as of the first
44 full pay period after the start of the sheriff's
45 non-successive term which begins on the first Monday after the
46 second Tuesday of January next after the sheriff's election
47 pursuant to Section 36-3-4. Thereafter, if the sheriff serves
48 a full non-successive four-year term and is re-elected to a
49 successive term, the sheriff shall receive a 7.5 percent
50 salary increase. Subsequently, the sheriff shall receive an
51 increase in the sheriff's then-existing salary in the amount
52 of 7.5 percent for any successive term to which the sheriff is
53 re-elected, effective as of the first full pay period after
54 the start of the sheriff's successive term.

55 (e) During each term in office, the sheriff shall
56 receive benefits regularly provided to employees of the

57 Madison County Commission, but shall not receive any
58 cost-of-living compensation increases.

59 (f) Other than as specified in this section, the
60 sheriff shall receive no other increases in compensation.

61 (g) The following shall apply to the individual serving
62 as sheriff on June 1, 2025:

63 (1) Beginning June 1, 2025, he or she shall receive an
64 increase in salary from his or her current compensation of one
65 hundred fifty-four thousand eighty-six dollars and forty cents
66 (\$154,086.40) per year to one hundred seventy thousand dollars
67 (\$170,000) per year.

68 (2) He or she shall also receive a 7.5 percent salary
69 increase for serving a second successive term in office,
70 resulting in a salary of one hundred eighty-two thousand seven
71 hundred fifty dollars (\$182,750) per year.

72 (3) Thereafter, if re-elected to a successive term, he
73 or she shall receive an increase in his or her then-existing
74 salary in the amount of 7.5 percent effective as of the first
75 full pay period after the start of his or her successive term.

76 (4) The provisions of this subsection shall be void
77 when the individual serving as sheriff on June 1, 2025, ceases
78 to serve as sheriff.

79 ~~(b) The Sheriff of Madison County shall not receive any~~
80 ~~monetary compensation of any kind other than reimbursements~~
81 ~~for itemized expenses and other than the annual salary set~~
82 ~~forth herein."~~

83 Section 2. This act shall become effective on June 1,
