- 13 Beginning at the Southeast corner of Section 23,

- distance of 1326.31 feet to a point, thence North 1°54'13"
- 16 East a distance of 661.42 feet to a point, thence South
- 17 87°11'54' East a distance of 1326.31 feet to a point, thence
