A BILL
TO BE ENTITLED
AN ACT

Relating to Cullman County; to alter, rearrange, and extend the boundary lines and corporate limits of the City of Cullman in Cullman County.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The boundary lines and corporate limits of the City of Cullman in Cullman County are altered and rearranged to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

PARCEL I:

Beginning at the Southeast corner of Section 23, Township 9 South, Range 4 West, thence North 87°11'54" West a distance of 1326.31 feet to a point, thence North 1°54'13" East a distance of 661.42 feet to a point, thence South 87°11'54" East a distance of 1326.31 feet to a point, thence South 1°54'13" West a distance of 661.42 feet to the point of beginning. Said land lying and being in the Southeast Quarter of the Southeast Quarter of Section 23, Township 9 South, Range 4 West, Cullman County, Alabama, and containing 20.14 acres, more or less.

PARCEL II:

Commence at the Northwest corner of the Northeast

Quarter of the Northeast Quarter, Section 26, Township 9 South, Range 4 West, thence North $87^{\circ}47'24''$ East a distance of 538.10 feet to a point and the true point of beginning, thence continue North $87^{\circ}47'24''$ East a distance of 788.21 feet to a point on the West right of way of a county road, thence South $1^{\circ}32'46''$ East along said right of way a distance of 1240.13 feet to a point, thence South $28^{\circ}55'06''$ West along said right of way a distance of 83.48 feet to a point, thence South $19^{\circ}01'32''$ West along said right of way a distance of 281.19 feet to a point on the North right of way of Alabama Highway 157, thence North $72^{\circ}59'$ West along said right of way a distance of 679.54 feet to a point, thence North $1^{\circ}40'$ West a distance of 1350.01 feet to the point of beginning.

Said land lying and being in the Northeast Quarter of the Northeast Quarter and the Southeast Quarter of the Northeast Quarter of Section 26, Township 9 South, Range 4 West, Cullman County, Alabama, and containing 26.17 acres, more or less.

Section 2. In accordance with Section 11-42-6 of the Code of Alabama 1975, a map showing the proposed territory to be altered, rearranged, and extended from the City of Cullman is on file and open to public inspection in the Office of the Judge of Probate in Cullman County, Alabama.

Section 3. This act shall become effective on October 1, 2025.
