1 Enrolled, An Act,

3 To alter, rearrange, and extend the boundary lines and 4 corporate limits of the Town of Pine Level in Autauga County. 5 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

6 Section 1. The boundary lines and corporate limits of 7 the Town of Pine Level in Autauga County are altered and 8 rearranged to include within the corporate limits of the 9 municipality, in addition to the lands now included, all of 10 the following territory:

Code of Alabama 1975, a map showing the proposed territory to

64 be altered, rearranged, and extended from the Town of Pine 65 Level is on file and open to public inspection in the Office 66 of the Judge of Probate in Autauga County, Alabama.

67 Section 3. This act shall become effective on October 68 1, 2025.
