3 EXTENDING THE CHRONIC WEIGHT MANAGEMENT AND TYPE 2 DIABETES
4 TASK FORCE.

6 WHEREAS, House Joint Resolution 163, enacted as Act
7 2023-260 of the 2023 Regular Session, created the Chronic
8 Weight Management and Type 2 Diabetes Task Force to study
9 the health implications of chronic weight management and
10 type 2 diabetes; and

11 WHEREAS, Act 2023-260 provided that the task force
12 would submit findings and recommendations to the Speaker of
13 the House of Representatives, the President Pro Tempore of
14 the Senate, and the chairs of the appropriate legislative
15 committees no later than the fifteenth legislative day of
16 the 2025 Regular Session, at which time the task force would
17 be dissolved; and

18 WHEREAS, the task force needs an additional year in
19 order to continue to develop recommendations relating to the
20 issue of health implications of chronic weight management
21 and type 2 diabetes; now therefore,

22 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
23 HOUSES THEREOF CONCURRING, That the Chronic Weight
24 Management and Type 2 Diabetes Task Force, created pursuant
25 to Act 2023-260, 2023 Regular Session, is extended.

26 (a) The task force shall prepare a report of its
27 findings and recommendations to the Speaker of the House of
28 Representatives, the President Pro Tempore of the Senate,

29 and the chairs of the appropriate legislative committees not
30 later than the fifteenth legislative day of the 2026 Regular
31 Session. Upon filing its report, the task force shall stand
32 dissolved and discharged of any future duties and
33 liabilities.

34 (b) Pursuant to Section 36-14-17.1, Code of Alabama
35 1975, the task force shall provide the Secretary of State a
36 notice of all meetings, the name of each member serving on
37 the task force, and a copy of the final report and any other
38 documents produced by the task force throughout its
39 duration.
