4 HR ____ MOURNING THE DEATH AND CELEBRATING THE LIFE OF FORMER
5 STATE REPRESENTATIVE MARY STEPHENS ZOGHBY.

7 WHEREAS, it is with profound sorrow that we note the 8 death of former State Representative Mary Stephens Zoghby of 9 Mobile, Alabama, on April 12, 2025, at the age of 86; and 10 WHEREAS, her departure leaves a void in the lives of

11 her loving family, many friends, and the community where she 12 was highly regarded; and

13 WHEREAS, Mary Elizabeth Stephens was born on July 23, 14 1938, in Gulfport, Mississippi; she was a lifelong and 15 devoted Catholic and attended St. John's High School in 16 Gulfport; she matriculated to the newly established 17 University of South Alabama in Mobile and became a member of 18 St. Pius X Catholic Church; and

19 WHEREAS, Mary Zoghby was an advertising executive 20 before running for a seat in the Alabama House of 21 Representatives in 1978 on a desegregation platform; she was 22 a dedicated public servant until 1994; and

23 WHEREAS, in 1985, Mary Zoghby was the chief sponsor 24 of legislation that restructured the Mobile governance from 25 an at-large, three commissioner system of city government to 26 a mayor/council form of government, which also required that 27 Mobile's budget be balanced; the adoption of the new 28 government helped resolve decades of litigation involving

29 voter suppression; the residents of Mobile affectionately 30 dubbed this legislation the "Zoghby Act"; and

WHEREAS, after leaving political office, Mary Zoghby 31 32 remained a committed public servant in her community; she 33 retired after two decades of service with the Boys and Girls Clubs of South Alabama, serving six years as its Resource 34 35 Development Director and 14 years as Executive Director; she 36 was recognized as Mobile's First Lady in 1986, Mobilian of 37 the Year in 1996, and was the recipient of the Liberty Bell 38 Award; she served on numerous charitable boards, including AltaPointe Health Systems, Catholic Social Services, the 39 Mobile Lion's Club, and the Children's Policy Council; and 40

WHEREAS, Mary Zoghby's life was characterized by intelligence, compassion, and an unwavering commitment to her community; she was predeceased by her husband, Mitchell P. Zoghby; and sister, Patti A. Stephens; her memory will be lovingly cherished by numerous nieces, nephews, friends, neighbors, and former colleagues; and

WHEREAS, although her presence will be greatly missed, the contributions of Mary Zoghby left an indelible mark on Mobile and will be remembered in the hearts of all who knew and loved her; now therefore,

51 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE 52 LEGISLATURE OF ALABAMA, That the death of former State 53 Representative Mary Stephens Zoghby is recorded with deep 54 sadness, and this resolution is offered to her family in 55 tribute to her life and with heartfelt sympathy to her loved 56 ones whose grief is shared by many.
