5 WILLIE AND BETTY FARRIOR FAMILY FOUNDATION HONOREES.

7 WHEREAS, highest commendations are extended to Ronald 8 Lee and Joan Garrett for being recognized as Willie and 9 Betty Farrior Family Foundation Honorees for their many 10 contributions to their community; and

11 WHEREAS, the foundation is named in honor of Willie 12 Farrior, the first African American hired by the Alabama 13 Institute for Deaf and Blind (AIDB) and the first African 14 American to be recognized as Blind Worker of the Year in 15 1973; in 1974, he was promoted to training instructor and became the first Black assistant supervisor for AIDB in 16 17 1979; in 2017, the foundation was established by his 18 daughter, Mary Louise Farrior-White and grandson, Retired 19 Colonel Cedrick A. Farrior; the foundation recognizes certain individuals who have selflessly contributed their 20 21 time for the betterment of their community; and

22 WHEREAS, Ronald Lee Garrett and Joan Garrett are 23 graduates of the Alabama School for the Blind in Talladega, 24 Alabama; Ronald attended Auburn University and The 25 University of Alabama in Birmingham, receiving a Bachelor of 26 Education, Master of Education, and Education Specialist 27 degree; Joan is a graduate of The University of Alabama in 28 Birmingham, Jacksonville State University, and Gadsden State



29 Community College; and

30 WHEREAS, Ronald served as Principal of the Alabama 31 School for the Blind; Joan served as the Regional Director 32 of the Talladega Regional Center Alabama Institute for the 33 Deaf and Blind of Talladega, Alabama; and

WHEREAS, community involvement for the couple 34 35 includes, but is not limited to, the following: AIDB alumni works, American Association for the Education and 36 Rehabilitation for the Blind and Visually Impaired, the Red 37 Door Kitchen Board of Directors, Alabama Institute for the 38 Deaf and Blind Board of Trustees, President of Local and 39 State Alabama Council of the Blind Organization, Exie Hill 40 41 Service Awards from the Alabama Council of the Blind, 42 Marguerite McKennon Service Award, and active members of 43 Central Baptist Church; now therefore,
