1 Enrolled, An Act,

3 Relating to the City of Scottsboro in Jackson County;  
4 to extend the terms of office of the Mayor of the City of  
5 Scottsboro, the members of the City Council of the City of  
6 Scottsboro, and the members of the Scottsboro City Board of  
7 Education for the purpose of revising the election dates for  
8 the general municipal election in the city.

9 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

10 Section 1. This act shall apply only to the City of  
11 Scottsboro in Jackson County.

12 Section 2. The terms of office of the members of the  
13 City Council of the City of Scottsboro set to expire in 2026  
14 shall be extended by one additional year to expire in 2027.  
15 Successors to the offices of members of the city council whose  
16 terms expire in 2027 shall be elected at the general municipal  
17 election to be held on the fourth Tuesday in August 2027, and  
18 every four years thereafter.

19 Section 3. The term of office of the Mayor of the City  
20 of Scottsboro set to expire in 2028 and the terms of office of  
21 the members of the City Council of the City of Scottsboro set  
22 to expire in 2028 shall be extended by one additional year to  
23 expire in 2029. A successor to the Office of Mayor and  
24 successors to the offices of members of the city council whose  
25 terms expire in 2029 shall be elected at a general municipal  
26 election to be held on the fourth Tuesday in August 2029, and  
27 every four years thereafter.

28 Section 4. The terms of office of members of the

29     Scottsboro City Board of Education set to expire in 2026 shall  
30     be extended by one additional year to expire in 2027.

31     Successors to the offices of members of the city board of  
32     education whose terms expire in 2027 shall be elected at the  
33     general municipal election to be held on the fourth Tuesday in  
34     August 2027, and every six years thereafter.

35             Section 5. The terms of office of members of the  
36     Scottsboro City Board of Education set to expire in either  
37     2028 or 2030 shall be extended by one additional year to  
38     expire in either 2029 or 2031, respectively. Successors to the  
39     offices of members of the city board of education shall be  
40     elected at the fourth Tuesday in either August 2029 or August  
41     2031, in the year the term of the member expires, and every  
42     six years thereafter.

43             Section 6. After the effective date of this act, if no  
44     candidate for mayor, member of the city council, or member of  
45     the city board of education receives a majority of votes cast  
46     in the regular municipal election, a second or run-off  
47     election shall be held on the fourth Tuesday following the  
48     regular election.

49             Section 7. All laws or parts of laws which conflict  
50     with this act are repealed.

51             Section 8. This act shall become effective June 1,  
52     2025.
