9	Relating to public K-12 education; to create the
10	Alabama Teacher Paperwork Streamlining Act; to require the
11	State Department of Education to develop a unified digital
12	platform and a system of data sharing that consolidates
13	documentation required by the Alabama Literacy Act, the
14	Alabama Numeracy Act, individualized education programs,
15	Section 504 Plans, and other educational programs; to provide
16	for a statewide teacher advisory committee; to require
17	compliance, and to repeal Section 16-6B-11, Code of Alabama
18	1975, providing for the creation and operation of the
19	Paperwork Reduction Committee.
20	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
21	Section 1. (a) This section shall be known and may be
22	cited as the Alabama Teacher Paperwork Streamlining Act.
23	(b) The purpose of this section is to accomplish all of
24	the following:
25	(1) Streamline and reduce the paperwork burdens placed
26	on Alabama teachers related to the required documentation for
27	the Alabama Literacy Act, the Alabama Numeracy Act,
28	individualized education Programs, plans developed under

- 30 (Section 504 Plans), and other educational programs.
- 31 (2) Improve teacher morale and retention by reducing
- 32 noninstructional administrative burdens.
- 33 (c) The State Department of Education shall do all of
- 34 the following:
- 35 (1) Work with local boards of education to create a
- 36 unified digital platform that consolidates the required
- 37 documentation for the Alabama Literacy Act, Alabama Numeracy
- 38 Act, individualized education programs, Section 504 Plans, and
- 39 other relevant educational programs into a single,
- 40 user-friendly system.
- 41 (2) Collaborate with stakeholders including, but not
- 42 limited to, teachers, administrators, and legal experts, to:
- a. Eliminate redundant documentation requirements
- 44 across different programs;
- 45 b. Standardize forms and reporting formats to reduce
- 46 complexity and time spent on paperwork; and
- 47 c. Ensure that documentation requirements align with
- 48 state and federal rules and regulations, while reducing
- 49 unnecessary paperwork.
- 50 (3) Develop and implement, beginning with the 2026-2027
- 51 school year, a system of data sharing among the Alabama
- 52 Literacy Act, the Alabama Numeracy Act, individualized
- education programs, Section 504 Plans, and other educational
- 54 programs to ensure that information entered once is able to be
- used across multiple documentation platforms to reduce
- 56 repetitive input by teachers.



57 (4) Annually review and audit all paperwork
58 requirements to assess if further streamlining is necessary.
59 The department shall actively solicit input from teachers
60 during the annual review process.

- (d) (1) The Alabama Public Education Paperwork Reduction Committee is created. The committee shall consist of teachers representing all grade levels and as many subject matters as practicable. The committee shall include one principal, one curriculum director, one special education coordinator, one instructional coach, and one interventionist. Not less than 75 percent of the membership of the committee shall consist of nonadministrative teachers actively engaged in full-time classroom instruction.
- (2) a. The organizational meeting of the committee shall be held no later than September 1, 2025. At the organizational meeting, and annually thereafter, the membership of the committee shall elect a chair from among its membership. The committee shall meet quarterly to assess the effectiveness of paperwork streamlining measures, offer recommendations for further improvement, and ensure that teachers' needs are being met in the areas of paperwork reduction. If more than 100 days have elapsed since the last meeting of the committee, a meeting may be called by the chair or by written petition of a majority of the membership of the committee.
- b. Members of the committee may participate in a meeting of the committee by means of telephone conference, video conference, or similar communications equipment by means of which all members participating in the meeting may hear



each other at the same time. Participation by such means shall constitute presence in person at a meeting for all purposes, including constituting a quorum.



- (3) The State Superintendent of Education shall solicit applications from teachers to serve on the committee. From those applications, the state superintendent shall submit recommendations to the State Board of Education for appointment to a two-year term. The nominating and appointing authorities shall coordinate their nominations and appointments to assure the committee membership is inclusive and reflects the racial, gender, geographic, urban, rural, and economic diversity of the state. Vacancies shall be filled in a like manner.
- 98 (4) The committee shall submit a report to the State 99 Superintendent of Education after each meeting. The report shall include recommendations for reducing paperwork 100 requirements for public school teachers and an overview 101 102 detailing the effectiveness of existing measures. The State 103 Superintendent of Education shall respond, in writing, to the 104 recommendations of the committee and shall submit each report, 105 with his or her response, to the State Board of Education for 106 discussion during the next board meeting. No additional 107 required paperwork mandate shall be implemented by the State 108 Department of Education or State Board of Education without 109 first vetting the requirement with and receiving approval from 110 the committee.
 - (5) Members of the committee shall not be compensated for their service but may be reimbursed their actual expenses



- for attending committee meetings. A local board of education
- shall provide any teacher appointed to the committee with
- 115 permission to attend committee meetings and may not deduct
- from that teacher's leave or pay for his or her attendance of
- 117 committee meetings.
- (e) (1) All local boards of education shall comply with
- 119 this section and the requirements developed by the department
- 120 regarding the use of the streamlined paperwork system. The
- 121 State Department of Education shall conduct annual audits to
- 122 ensure compliance with these requirements.
- 123 (2) Any local board of education failing to implement
- 124 the streamlined documentation system shall face corrective
- 125 action including, but not limited to, retraining of
- 126 administrators or other measures to ensure compliance with
- 127 this section.
- 128 (f) The Legislature shall allocate necessary funding to
- 129 the State Department of Education to support the development
- and maintenance of the unified digital platform, training for
- 131 teachers, and support for local boards of education in
- 132 streamlining paperwork.
- Section 2. Section 16-6B-11, Code of Alabama 1975,
- providing for the creation and operation of the Paperwork
- 135 Reduction Committee, is repealed.
- 136 Section 3. This act shall become effective on June 1,
- 137 2025.
