7	Relating to Lauderdale County; to alter, rearrange, and
8	extend the boundary lines and corporate limits of the City of
9	Florence in Lauderdale County.
10	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
11	Section 1. The boundary lines and corporate limits of
12	the City of Florence in Lauderdale County are altered and
13	rearranged to include within the corporate limits of the
14	municipality, in addition to the lands now included, all of
15	the following territory:
16	<u>Parcel</u>
17	Being a parcel of land located in the Southeast 1/4 of
18	Section 25, Township 2 South, Range 11 West, and the Northeast
19	1/4 of Section 36, Township 2 South, Range 11 West, and the
20	South 1/2 of Section 30, Township 2 South, Range 10 West, and
21	the North 1/2 of Section 31, Township 2 South, Range 10 West,
22	Lauderdale County, Alabama, being further described as:
23	Beginning at a point on the southeast corner of parcel
24	no. 16-09-30-0-001-009.000, said point being on the north part
25	of the 60 foot right-of-way line of Gresham Road and on the
26	west right-of-way line of County Road 61; thence south 60 feet
27	crossing Gresham Road to a point on the south part of the 60

foot right-of-way line of Gresham Road; thence westwardly

29	along said south right-of-way line (following a curve on the
30	west end of Gresham Road) a distance of 6,153 feet to a point
31	(said point being on the north right-of-way line of AL Hwy
32	133); thence northwest 60 feet along said AL Hwy 133
33	right-of-way line crossing Gresham Road to a point on the
3 4	north part of the 60 foot right-of-way line of Gresham Road;
35	thence north and eastwardly along said right-of-way line
36	(following a curve on the west end of Gresham Road) a distance
37	of 6,233 feet to the point of beginning.
38	Said parcel to convey a 60 foot wide right-of-way along
39	Gresham Road from AL Hwy 133 going east to County Road 61.
10	Section 2. In accordance with Section 11-42-6 of the
11	Code of Alabama 1975, a map showing the proposed territory to
12	be altered, rearranged, and extended from the City of Florence
13	is on file and open to public inspection in the office of the
14	Judge of Probate in Lauderdale County, Alabama.
15	Section 3. This act shall become effective on October
16	1. 2025.
