- (f) Other than as specified in this section, the
 sheriff shall receive no other increases in compensation.
- (g) The following shall apply to the individual serving as sheriff on June 1, 2025:
 - (1) Beginning June 1, 2025, he or she shall receive an increase in salary from his or her current compensation of one hundred fifty-four thousand eighty-six dollars and forty cents (\$154,086.40) per year to one hundred seventy thousand dollars (\$170,000) per year.
 - (2) He or she shall also receive a 7.5 percent salary increase for serving a second successive term in office, resulting in a salary of one hundred eighty-two thousand seven hundred fifty dollars (\$182,750) per year.
 - (3) Thereafter, if re-elected to a successive term, he or she shall receive an increase in his or her then-existing salary in the amount of 7.5 percent effective as of the first full pay period after the start of his or her successive term.
 - (4) The provisions of this subsection shall be void when the individual serving as sheriff on June 1, 2025, ceases to serve as sheriff.
- 79 (b) The Sheriff of Madison County shall not receive any
 80 monetary compensation of any kind other than reimbursements
 81 for itemized expenses and other than the annual salary set
 82 forth herein."
- Section 2. This act shall become effective on June 1, 2025.
