9	Relating to driver licenses; to invalidate the use of
10	certain classes of driver licenses; to amend Section 32-6-2,
11	Code of Alabama 1975; to prevent certain individuals from
12	qualifying for certain driver license exemptions.
13	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
14	Section 1. (a) A driver license of a class issued
15	exclusively to individuals who did not exercise the option of
16	providing proof of lawful presence in the United States when
17	obtaining the license is not valid in this state and does not
18	authorize the holder to operate a motor vehicle in this state.
19	(b) A law enforcement officer who stops an individual
20	driving with a license as described in subsection (a) shall
21	issue a citation to the individual for driving without a
22	license pursuant to Section 32-6-18, Code of Alabama 1975,
23	unless the individual has in his or her possession other
24	documentation showing proof of lawful presence in the United
25	States.
26	(c) To facilitate the enforcement of this section and
27	to aid in providing notice to visitors and the general public

29 Enforcement Agency shall maintain on its website a statement 30 summarizing this section.

31 (d) The Alabama State Law Enforcement Agency shall 32 design and the State Department of Transportation shall 33 install signage anywhere there is a sign welcoming drivers to 34 the State of Alabama to give notice regarding the provisions 35 of this section.

36 Section 2. Section 32-6-2, Code of Alabama 1975, is 37 amended to read as follows:

38 "\$32-6-2

The following persons <u>individuals</u>, when driving a motor vehicle under the following conditions, are exempt from <u>a the</u> requirement to obtain a driver license <u>hereunder</u>:

42 (1) Any <u>person_individual</u> in the service of the federal 43 government while driving an official motor vehicle in such 44 service;.

45 (2) Any person <u>individual</u> while driving any road
46 machine, farm tractor, or implement of husbandry temporarily
47 driven or moved on a highway;.

(3) A nonresident who is at least 16 years of age and 48 49 who has in his or her immediate possession a valid driver's 50 driver license issued in his or her home state or country+. 51 This exemption does not apply if the nonresident's license is 52 invalid under Section 1 of the act amending this section. 53 (4) Any nonresident who is at least 16 years of age whose home state or country does not require the licensing of 54 drivers for a period of not more than 90 days in any calendar 55

56 year, if the motor vehicle so driven is duly registered in the



- 57 home state or country of such nonresident."
- 58 Section 3. This act shall become effective on October
- 59 1, 2025.
