5 ACHIEVEMENT AND DEDICATED PUBLIC SERVICE.

7 WHEREAS, highest commendation is herein conveyed to
8 Martin Franklin Caskey in recognition of his exemplary
9 record of achievement and service to the Alabama Legislature
10 and the citizens of the State of Alabama during a
11 distinguished professional career with the Legislative
12 Services Agency, formerly the Legislative Reference Service;
13 and

14 WHEREAS, Frank Caskey began his legislative career in
15 1970 when, while still a senior at Lanier High School, he
16 worked as a clerk for Senator James B. Allen in Washington,
17 D.C.; he continued the clerkship while he was a freshman at
18 the University of Maryland; and

19 WHEREAS, Frank Caskey continued his higher education
20 at Auburn University where he worked in a cooperative
21 education program as a legislative aide with the Alabama
22 Legislature; he graduated with a Bachelor of Science in
23 Accounting in 1974, earning membership in the prestigious
24 honor society of Phi Kappa Phi; and

25 WHEREAS, commencing in June 1974 until December 1979,
26 Frank worked as a legislative analyst with the Alabama
27 Legislative Reference Service; he joined other attorneys in
28 the historic State Capitol building, drafting and

researching for this august body in a single large room with desks abutting and multiple conversations transpiring; he continued this work while working toward his Juris Doctor, which he earned from The University of Alabama in 1978; and

WHEREAS, taking a break from the legislative arena, Frank pursued a successful private practice from 1980 through 1987; he then joined and worked as an attorney with the law firm of Capouano, Wampold, Prestwood and Sansone in 1988; beginning in 1990, he briefly served as legal counsel for the Alabama State Employees Association before returning to the legislative work he truly loved at the State House; and

WHEREAS, Frank returned to the Legislative Reference Service in 1992, bringing a much-needed knowledge of private practice and court room experience to the agency; he utilized his expertise to provide a perspective that differed from his colleagues, offering a diverse skill set and sense of balance to the drafting team; through the years, he has made valued contributions to the legislative process and public administration; his practical and analytical approach to complex legal and constitutional issues, coupled with his legal knowledge and vast experience in all facets of state and local government, has been an instrumental component in his immeasurable success as a respected advisor to members and others in the legislative community and beyond; and

WHEREAS, throughout his employment with the Legislative Services Agency, he has developed expertise

63 is evident by the vast number of existing statutes crafted
64 by his measured hand; and

66 Legislature, Frank served as an adjunct professor teaching
67 administrative law at the Jones School of Law and The
68 University of Alabama School of Law for over 20 years; even
69 when his tenure as a teacher ended, he continued to provide
70 vital mentorship and support for students and young
71 attorneys; and

72 WHEREAS, a steadfast presence to his colleagues in
73 the midst of legislative chaos, coworkers who have shared
74 the back halls of the birthplace of legislation with Frank
75 will forever appreciate his innate ability to remember
76 previous legislation, by date and member, all while
77 articulately spinning an original solution to a troubling
78 legal problem; his institutional knowledge of the
79 Legislature is unmatched; his counsel is highly regarded by
80 legislators, lobbyists, and fellow attorneys alike; and

81 WHEREAS, Frank Caskey unquestionably represents
82 excellence, intelligence, and unwavering commitment to the
83 duties he professionally and proficiently performed on a
84 daily basis; his abilities, vast knowledge, memory, tireless
