4	SJR HONORING DANIEL PRATT AS ALABAMA'S FIRST GREAT
5	INDUSTRIALIST.
6	
7	WHEREAS, Daniel Pratt, born in 1799 in Temple, New
8	Hampshire, was a visionary, industrialist, workforce
9	developer, landscape architect, and philanthropist who
10	profoundly influenced the State of Alabama; and
11	WHEREAS, Daniel Pratt, after receiving training as a
12	carpenter, traveled to the southern United States and
13	eventually settled in Alabama, where he founded the town of
14	Prattville in 1838, transforming a swampy landscape into a
15	thriving industrial hub; businesses he started include a
16	grist mill; a woolen mill; blacksmith shop; sawmill; horse
17	mill shop; door, sash, and blind shop; a carriage and wagon
18	shop; tin shop; foundry; general store; cotton mill; and a
19	mercantile, among others; and
20	WHEREAS, Daniel Pratt is credited with building the
21	first dam in Alabama; his purpose as a community builder was
22	to enhance its generational residents with a lifestyle of
23	growth, spiritually, mentally, and physically; his plan was
24	to develop a modernized workforce to populate his first
25	industrial manufacturing business; and
26	WHEREAS, he was also a champion of, and charter
27	investor for, railroads noting that Alabama had health and
28	water power, but lacked the third leg of the stool:



- 29 accessibility to market; and
- 30 WHEREAS, he established the Daniel Pratt Gin Company,
- 31 which became the largest manufacturer of cotton gins in the
- 32 world, setting new standards for industrial excellence and
- 33 contributing to the economic development of Alabama; his
- internationally renowned gin company operated for nearly 180
- years, from 1833 to 2012, under successor names such as the
- 36 Continental Gin Company and the Continental Eagle
- 37 Corporation; and
- 38 WHEREAS, a devout and steadfast Christian, Daniel
- 39 Pratt was deeply committed to philanthropy, providing land
- 40 and funds for the construction of schools and churches, and
- 41 promoting cultural enrichment through libraries, music
- 42 societies, and art galleries for the benefit of his
- 43 community; and
- WHEREAS, although Mr. Pratt died in 1873, his gin
- 45 factory remained active on the global stage, driving
- 46 industrial innovation and expanding into new sectors; his
- 47 son-in-law, Henry Fairchild DeBardeleben, carried forward
- 48 Pratt's vision, spearheading the growth of the iron and coal
- 49 industry in what would become Birmingham; and
- 50 WHEREAS, Daniel Pratt's remarkable contributions to
- 51 the development of Alabama's iron and coal region are
- 52 honored through the naming of industrial ventures such as
- 53 the Pratt Coal & Coke Company, Pratt Coal & Iron Company,
- Pratt Mines, and the Pratt Seam, which fostered the growth
- of Pratt City; the success of Alabama's iron and coal
- industries is deeply rooted in Pratt's visionary efforts to



57	develop the state's mineral resources; and
58	WHEREAS, in addition to manufacturing cotton gins,
59	the Continental Gin Company (CGC) became one of the first
60	southern industries to produce munitions for World War II;
61	recognized for both the quality and quantity of its
62	production, CGC was awarded the United States Navy's
63	prestigious "E" Flag for Excellence six times throughout the
64	war; to further support its wartime operations, the company
65	maintained a full-time office in Washington, D.C., for the
66	entire four-year duration; and
67	WHEREAS, CGC played a crucial role in the Manhattan
68	Project by providing heavy piping for the atomic energy
69	program at Oak Ridge demonstrating its commitment to
70	advancing national interests; and
71	WHEREAS, the Daniel Pratt/Continental Gin Company
72	collection includes engineering drawings of numerous types
73	of bombshells, munitions, artillery mounts, turrets, and
74	shields manufactured at CGC plants, highlighting its
75	significant contributions to military manufacturing; and
76	WHEREAS, from 1926 to 1959, CGC was owned by the
77	Woodruff family of Atlanta, best known for their ownership
78	of Coca-Cola; showcasing CGC's versatility in manufacturing,
79	the Daniel Pratt/Continental Gin Company collection includes
80	engineering drawings for Coca-Cola dispensers from the 1940s
81	and 1950s; and
82	WHEREAS, Daniel Pratt was Alabama's first great
83	industrialist and established Prattville as Alabama's first
84	industrial village, laying the foundation for the state's



- 85 economic growth; and
- 86 WHEREAS, Daniel Pratt played a pivotal role in the
- 87 design and construction of the 1851 Alabama State Capitol as
- the lead commissioner, shaping the state's most iconic
- 89 government building; and
- 90 WHEREAS, a copy of Mr. Pratt's architectural drawing
- of the Capitol is preserved at the Prattaugan Museum, and
- 92 the circular cantilevered staircases found within the
- 93 Capitol were a standard architectural feature in the homes
- 94 Pratt designed and built in Georgia before coming to
- 95 Alabama, as well as in homes he built in Autauga County; and
- 96 WHEREAS, Horace King, the renowned bridge builder
- 97 credited with constructing the Capitol's staircases, was
- 98 known to Mr. Pratt from his time in Georgia, and Mr. Pratt
- 99 provided Mr. King with a \$100 model used in the construction
- 100 of the Chattahoochee River covered bridge in the early
- 101 1830s; and
- 102 WHEREAS, in 1846, Pratt constructed a three-story
- 103 building on St. Charles Street in New Orleans to house
- 104 cotton gins being shipped to France, Russia, Africa, the
- 105 United Kingdom, and Mexico, demonstrating his company's
- 106 global reach and influence; and
- 107 WHEREAS, Daniel Pratt co-founded the Red Mountain
- 108 Iron & Coal Company in 1862 and faithfully served as its
- 109 president; and
- 110 WHEREAS, recognizing the financial difficulties of
- 111 reconstruction, Daniel Pratt partnered in opening the
- 112 Wheless-Pratt Bank in New Orleans in 1867; and



113	WHEEREAS, IOIIOWING the Civil War in 1867, Daniel
114	Pratt was selected to chair the first meeting of the
115	National Association of Textile Manufacturers in New York
116	City, underscoring his prominence in industrialism; and
117	WHEREAS, Daniel Pratt was honored with the first
118	honorary degree of Master of Mechanical and Useful Arts by
119	The University of Alabama, recognizing his extraordinary
120	contributions to industry and public welfare; and
121	WHEREAS, though not having the benefit of a formal
122	education himself, Pratt expressed in a private letter that,
123	"No man holds education in a higher estimation than myself";
124	and
125	WHEREAS, Daniel Pratt served as a member of the
126	Alabama House of Representatives and continued to invest and
127	encourage all to invest in the state's infrastructure and
128	economic growth throughout his life; and
129	WHEREAS, mindful of his Christian duty, Daniel Pratt
130	declared, "Some pretend to show their works by their faith I
131	hope to show my faith by my works, so long as God blesses me
132	with health and strength"; and
133	WHEREAS, Daniel Pratt was renowned as a great
134	industrialist, but he also earned recognition as a Southern
135	Renaissance man; an advocate for education, he was an
136	architect, patron of the arts, economic developer,
137	statesman, philanthropist; now therefore,
138	BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
139	HOUSES THEREOF CONCURRING, That we celebrate the life and
140	legacy of Daniel Pratt as Alabama's first great



141	industrialist, whose pioneering achievements in business,
142	manufacturing, infrastructure, and community service have
143	left an enduring mark on the State of Alabama and continue
144	to inspire future generations.
145	BE IT FURTHER RESOLVED, That it is our duty to follow
146	the example of Daniel Pratt and continue to invest in our
147	communities through our faith, our family, and our fellow
148	man.
