8	WHEREAS, it is with profound sorrow that we note the
9	death of William Jelks "Bill" Cabaniss, Jr. of Birmingham,
10	Alabama, on February 2, 2025, at the age of 86; and
11	WHEREAS, his departure leaves a void in the lives of
12	his loving family, many friends, and the community where he
13	was highly regarded; and
14	WHEREAS, Bill Cabaniss was born in 1938 in Birmingham
15	to William Jelks Cabaniss, Sr. and Florence Pierson Sanson
16	Cabaniss; he graduated from the Lawrenceville School in New
17	Jersey in 1956 and matriculated to Vanderbilt University,
18	graduating in 1960; he trained in Vanderbilt's ROTC program
19	and was commissioned a Second Lieutenant in the United
20	States Army; he served as an Airborne Ranger for three years
21	of active duty in Germany; and in 1964, he was awarded the
22	Army Commendation Medal; and
23	WHEREAS, in 1962, Bill Cabaniss married his wife of
24	58 years, Catherine Hood Caldwell; they shared an
25	extraordinary life together, beginning in Zweibrucken,
26	Germany; after Bill's honorable discharge from active duty,

30	WHEREAS, concerned about Alabama's relationship to
31	business, Bill Cabaniss ran for and won a seat in the
32	Alabama House of Representatives in 1978; in 1982, he was
33	elected to the Alabama State Senate and served eight years;
34	he supported many bipartisan bills that most benefited the
35	citizens of Alabama; his peers voted him one of five
36	outstanding state senators; and
37	WHEREAS, State Senator Cabaniss attempted a run for
38	the U.S. Senate and, although he was unsuccessful, he gained
39	the friendship of President George W. Bush who appointed him
40	Ambassador to the Czech Republic; he served that post with
41	distinction from 2004 to 2006, further cementing ties
42	between the two democracies; he traveled and lectured
43	throughout Europe on behalf of the United States and the
44	Czech Republic; he maintained a friendship with President
45	Vaclav Klaus and upon returning home, he became involved in
46	several not-for-profit organizations in Prague and New York;

48	WHEREAS, he was active in his Birmingham community
49	and served on the boards of directors for several notable
50	firms; he chaired the Metropolitan Development Board and the
51	Board of Junior Achievement of Jefferson County; he was
52	inducted into the Alabama Academy of Honor in 2004 and the
53	Alabama Business Hall of Fame in 2006; he served faithfully
54	as Senior Warden at Saint Luke's Episcopal Church for many
