| 6  | WHEREAS, we desire to build upon our heritage in             |
| 7  | making Alabama a place where families are strong, homes and  |
| 8  | streets are safe, education is effective, business is        |
| 9  | productive, neighbors care about one another, and citizens   |
| 10 | are free to make wise choices for their lives and families;  |

| 12 | WHEREAS, we recognize that individuals are                   |
| 13 | responsible for their actions, and that daily decisions      |
| 14 | should be based upon sound timeless values that are the      |
| 15 | basis of universally recognized character qualities,         |
| 16 | including kindness, courage, loyalty, diligence, generosity, |
| 17 | truthfulness, honesty, and obedience; and                    |
| 18 | WHEREAS, irresponsibility and a lack of commitment to        |
| 19 | these values have resulted in an increasing number of family |
| 20 | problems causing personal, social, and financial             |
| 21 | consequences to individual family members and to society as  |
| 22 | a whole; and   |
| 23 | WHEREAS, when people fail to demonstrate positive            |
| 24 | character qualities or make poor moral choices, the health,  |
| 25 | safety, and welfare of the citizens are endangered,          |
| 26 | resulting in financial burden upon the taxpayers for the     |
| 27 | costs of lower productivity and increased social services    |
| 28 | and law enforcement; many current societal problems will be  |

alleviated when citizens live by positive and constructive character qualities that distinguish between right and wrong, and it has been shown that teaching and reinforcing positive character qualities to juvenile delinquents produces a change of behavior, reducing recidivism rates; and

35 WHEREAS, our prisons far exceed planned capacity and 36 there is a need for more positive role models among our 37 young people to discourage juvenile delinquency and for 38 these individuals to understand those qualities that have 39 made our country strong and prosperous; and

40 WHEREAS, our schools should be safe climates in which 41 character is exemplified, taught, and strengthened, and 42 learning is encouraged; and

43 WHEREAS, the Alabama Superintendent's Commission on 44 Citizenship and Character Education recommendation is to 45 develop strategies to encourage partnerships between LEAs 46 and Alabama stakeholders for the "Alabama, A State of 47 Character" movement; and

WHEREAS, encouraging employees by recognizing positive character qualities has resulted in an increase in workplace morale, employee safety, and corporate profits; such action is essential as Alabama competes for 21st Century jobs with states in which character is emphasized; and

54 WHEREAS, presidents throughout our nation's history 55 have promoted character principles and have encouraged 56 character education as a high priority for America's



57 schools; many other highly regarded civic leaders have 58 extolled character as among the qualities by which all 59 people should be judged; and

60 WHEREAS, the Alabama Legislature must address the 61 challenge of allocating and stretching very limited 62 resources very far, because of education and social needs; 63 and

64 WHEREAS, the Alabama Legislature has repeatedly 65 appealed for the promotion of character-building strategies 66 through its approval of "Alabama, a State of Character" 67 resolutions in 2000, 2005, 2008, 2014, 2018, and 2022 and 68 the Alabama House of Representatives in 2011; and

69 WHEREAS, the Alabama Legislature again appeals for 70 character-building strategies to be promoted in a 71 collaborative way by partners, and we, as Alabama lawmakers, 72 again appeal for there to be creative efforts to support and 73 promote practical and affordable strategies for this state 74 which will help Alabama to take the lead with the "States of 75 Character" movement; now therefore,

BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH 76 77 HOUSES THEREOF CONCURRING, That we reaffirm our 2000, 2005, 78 2008, 2014, 2018, and 2022 declarations of Alabama as a State of Character, and appeal to partners to collaborate 79 80 when developing and supporting the implementation of 81 character building strategies; as Alabama leaders, we agree to support the development of "State of Character" 82 83 strategies and to encourage cooperation with other legally declared States of Character for the States of Character 84



85 movement to positively influence our nation; we pledge to do 86 all in our power to promote this Alabama, A State of 87 Character resolution and character education in our schools, 88 businesses, homes, churches, local governments, state 89 agencies, media, and community groups, and we urge leaders 90 of each of these areas to do likewise.
