**Senate Bill 226** (Act 2026-609) as enacted appropriates the following amounts for fiscal year 2026:

- 1) \$387,500,000 from the Public Road and Bridge Fund to the Alabama Department of Transportation;
- 2) \$200,000,000 from the Rebuild Alabama Fund to the Alabama Department of Transportation;
- 3) \$50,000,000 from the Strategic Energy Infrastructure Development Fund to the State Industrial Development Authority;
- 4) \$35,137,949 from the Legislative Council Fund to the Legislative Council;
- 5) \$34,000,000 from the American Rescue Plan Act – State Small Business Credit Initiative Fund to the Department of Finance;
- 6) \$30,000,000 from the Broadband Accessibility Fund to the Alabama Department of Economic and Community Affairs;
- 7) \$22,137,949 from the Refundable Tax Credit Fund to the Legislative Council Fund;
- 8) \$16,000,000 from the Alabama Energy Infrastructure Fund to the State Industrial Development Authority;
- 9) \$13,000,000 from the Real Property Management Fund to the Legislative Council Fund;
- 10) \$4,100,000 from the State Judicial Administration Fund to the Unified Judicial System;



- 11) \$3,600,000 from the Administrative Office of Courts Federal and Local Funds Fund to the Unified Judicial System;
- 12) \$2,300,000 from the Court Automation Fund to the Unified Judicial System;
- 13) \$2,000,000 from the Bureau of Tourism and Travel Fund to the Alabama Site Development Fund;
- 14) \$2,000,000 from the Alabama Site Development Fund to the State Industrial Development Authority;
- 15) \$1,268,538 from the Personnel Fund to the State Personnel Department;
- 16) \$1,000,000 from the Advanced Technology and Data Exchange Fund to the Unified Judicial System;
- 17) \$1,000,000 from the Vaping and Licensing Enforcement Fund to the Alabama Alcoholic Beverage Control Board;
- 18) \$1,000,000 from the Consumable Hemp Product Compliance Fund to the Alabama Alcoholic Beverage Control Board;
- 19) \$1,000,000 from the Bureau of Tourism and Travel Fund to the Game and Fish Fund;
- 20) \$1,000,000 from the Game and Fish Fund to the Alabama Department of Conservation and Natural Resources;
- 21) \$750,000 from the Youth Services Reimbursement Fund to the Department of Youth Services;
- 22) \$588,612 from the Federal Stimulus Fund to the Alabama Medicaid Agency;
- 23) \$50,000 from the Geological Survey Library Revolving Fund to the Geological Survey of Alabama; and
- 24) \$32,000 from the Genetic Counseling Fund to the Alabama Board of Genetic Counseling.



In addition, this act amends Section 3C of Act 2025-251, the Fiscal Year 2025 General Fund Appropriations Act, to increase the appropriation for the repayment of bonds issued by the Alabama Federal Aid Highway Finance Authority, Alabama Highway Finance Corporation, the Alabama Industrial Access Road and Bridge Corporation or the Alabama Highway Authority by \$59,808,596 for a total of \$193,564,457.
