4 SYNOPSIS:

5           This bill makes an appropriation of \$169,633  
6       from the State General Fund to the Coalition Against  
7       Domestic Violence for the fiscal year ending September  
8       30, 2027, to require an operations plan and an audited  
9       financial statement prior to the release of any funds,  
10      and to require quarterly and end of the year  
11      performance reports.

18       To make an appropriation of \$169,633 from the State  
19      General Fund to the Coalition Against Domestic Violence for  
20      the fiscal year ending September 30, 2027, to require an  
21      operations plan and an audited financial statement prior to  
22      the release of any funds, and to require quarterly and end of  
23      the year performance reports.

24 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

25       Section 1. For the fiscal year ending September 30,  
26      2027, there is hereby appropriated to the Coalition Against  
27      Domestic Violence from the State General Fund the sum of  
28      \$169,633. In addition, the appropriation made herein shall be

29 budgeted and allotted pursuant to the Budget Management Act  
30 and Article 4 of Title 41 of the Code of Alabama, 1975, and  
31 specifically Section 41-4-93, Section 41-4-95 and Section  
32 41-4-96.

33       Section 2. Prior to the release of any funds  
34 appropriated under this bill for fiscal year 2027, an  
35 operations plan for fiscal year 2027 and an audited financial  
36 statement for all operations during fiscal year 2025 must be  
37 forwarded to the Director of Finance. It is the intent to  
38 release fiscal year 2027 funds following receipt of these  
39 reports.

40       Section 3. In addition, quarterly reports for fiscal  
41 year 2027 shall be made to the Director of Finance relating to  
42 planned expenditures and accomplishments. An end of year  
43 performance report for the fiscal year 2027 shall be made to  
44 the Director of Finance stating the work accomplished and  
45 services provided and the costs of accomplishing the work and  
46 providing the services, citing meaningful measures of program  
47 effectiveness and costs, as is required for state agencies in  
48 Code of Alabama 1975, Section 41-19-11. The Director of  
49 Finance shall forward a copy of all required reports to the  
50 Legislative Council in a timely manner.

51       Section 4. This act shall become effective October 1,  
52 2026.
