11 To make supplemental appropriations from the Education
12 Trust Fund Advancement and Technology Fund for the fiscal year
13 ending September 30, 2026, to the public institutions of
14 higher education in the amount of \$275,100,000, and to the
15 Department of Education, the Board of Trustees of the Alabama
16 Institute for Deaf and Blind, the Board of Youth Services
17 School Districts, the Board of Directors of the Alabama School
18 of Fine Arts, the Board of Trustees of the Alabama School of
19 Math and Science, the Board of Trustees of the Alabama School
20 of Cyber Technology and Engineering, and the Board of Trustees
21 of the Alabama School of Healthcare Sciences in the amount of
22 \$624,900,000, and to the Department of Education in the amount
23 of \$100,000,000.

24 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

25 Section 1. In addition to all other appropriations
26 heretofore or hereafter made, there is hereby appropriated a
27 total of \$275,100,000 from the Education Trust Fund
28 Advancement and Technology Fund to the public institutions of

higher education for the fiscal year ending September 30, 2026. This appropriation shall be expended as provided in Section 29-9-4, Code of Alabama 1975. This appropriation shall be distributed as follows:

50 heretofore or hereafter made, there is hereby appropriated a
51 total of \$624,900,000 from the Education Trust Fund
52 Advancement and Technology Fund to the Department of
53 Education, the Board of Trustees of the Alabama Institute for
54 Deaf and Blind, the Board of Youth Services School Districts,
55 the Board of Directors of the Alabama School of Fine Arts, the

56 Board of Trustees of the Alabama School of Math and Science,
57 the Board of Trustees of the Alabama School of Cyber
58 Technology and Engineering, and the Board of Trustees of the
59 Alabama School of Healthcare Sciences, for the fiscal year
60 ending September 30, 2026. This appropriation shall be
61 expended as provided in Section 29-9-4, Code of Alabama 1975.

62 Section 3. (a) The Department of Education shall
63 allocate the funds appropriated herein to the local boards of
64 education and entities as follows:

229 (b) Notwithstanding any other laws to the contrary, the

230 funds appropriated to the Department of Education by
 231 subsection (a) of this section shall not be expended without
 232 prior approval of the State Superintendent of Education.

233 (c) (1) The above appropriation for teacher professional
 234 development shall be allocated to the Alabama Department of

235 Education to be distributed to the Ed Farm Classroom of
236 Tomorrow. These funds will be used by Ed Farm to provide
237 technology tools and professional development services to
238 classroom teachers in an effort to improve instruction and
239 student learning gains. It is the intent of the legislature
240 that in addition to general programmatic costs, Ed Farm may
241 also expend funds for software, hardware, administrative
242 costs, and professional learning services.

243 (2) The State Superintendent shall provide a report of the
244 initiative to the Chair of the House Ways and Means-Education
245 Committee and the Chair of the Senate Committee on Finance and
246 Taxation-Education no later than October 1, 2027.

247 Section 4. (a) Notwithstanding the provisions of
248 Section 29-9-4, Code of Alabama 1975, and in addition to all
249 other appropriations heretofore or hereafter made, there is
250 hereby appropriated a total of \$100,000,000 from the Education
251 Trust Fund Advancement and Technology Fund to the Department
252 of Education to provide matching grants to local education
253 agencies for expenses related to developing regional career
254 technology centers throughout the state, including capital
255 outlay and equipment, for the fiscal year ending September 30,
256 2026. Grant proposals shall be submitted by a collaboration of
257 at lease two local education agencies. The State
258 Superintendent of Education shall utilize a sliding scale of

259 matching requirements for grant proposals, taking into
260 consideration the financial capacity of the eligible local
261 education agencies to provide matching funds, so long as the
262 required match does not exceed 50 percent of the total cost of
263 the project.

264 (b) The State Superintendent of Education shall notify
265 each local superintendent and finance officer of each local
266 education agency by email regarding the availability and
267 application process of grants to be awarded pursuant to this
268 section, including any required forms. The State
269 Superintendent shall notify all members of the local
270 legislative delegation five days prior to the announcement of
271 any grant made to any entity located in the legislative
272 jurisdiction. The five days prior notice requirement shall be
273 waived in the event of a declared emergency. The Governor
274 shall encourage the Department to disburse the funds provided
275 herein on a nondiscriminatory basis.

276 Section 5. All funds appropriated herein and not
277 expended in the current fiscal year shall not revert but be
278 carried forward for the purpose appropriated.

279 Section 6. This act shall become effective immediately
280 following its passage and approval by the Governor, or its
281 otherwise becoming law.
