1 SYNOPSIS:

2 This bill makes an appropriation of \$460,000
3 from the Education Trust Fund to Southern Preparatory
4 Academy in Camp Hill, Alabama for the support and
5 maintenance of the educational program of the
6 institution, for the fiscal year ending September 30,
7 2027; to provide that the appropriation is subject to
8 certain provisions of the Code of Alabama 1975; to
9 require an operations plan and an audited financial
10 statement prior to the release of any funds; and to
11 require an end of year report.

18 To make an appropriation of \$460,000 from the Education
19 Trust Fund to Southern Preparatory Academy in Camp Hill,
20 Alabama for the support and maintenance of the educational
21 program of the institution, for the fiscal year ending
22 September 30, 2027; to provide that the appropriation is
23 subject to certain provisions of the Code of Alabama 1975; to
24 require an operations plan and an audited financial statement
25 prior to the release of any funds; and to require an end of
26 year report.

27 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

28 Section 1. There is hereby appropriated the sum of

29 \$460,000 from the Education Trust Fund to Southern Preparatory
30 Academy in Camp Hill, Alabama for the support and maintenance
31 of the educational program of the institution, for the fiscal
32 year ending September 30, 2027.

33 Section 2. The above appropriation is made for the
34 support of public education in Alabama and for the support and
35 maintenance of the above program. The appropriation shall be
36 subject to the provisions, terms, conditions, and limitations
37 of the Budget and Financial Control Act, Code of Alabama 1975,
38 Section 41-4-80 et seq.; the provisions of the Budget
39 Management Act of 1976, Code of Alabama 1975, Sections 41-19-1
40 et seq.; and any other provisions of this act.

41 Section 3. (a) Prior to the release of any funds
42 appropriated under this act, the following reports shall be
43 submitted:

44 (1) An operations plan for the fiscal year 2027,
45 including goals and measurable performance indicators, shall
46 be submitted to and approved by the Director of Finance, as
47 provided for state agencies in Code of Alabama 1975, Section
48 41-19-10.

49 (2) An audited financial statement for all operations
50 during the fiscal year 2025.

51 (b) It is the intent that funds appropriated for fiscal
52 year 2027 shall be released by the Director of Finance
53 following receipt of the above reports.

54 (c) In addition, quarterly reports shall be made to the
55 Director of Finance relating actual expenditures and
56 accomplishments to planned expenditures and accomplishments.

57 An end of year performance report for the fiscal year 2027
58 shall be made to the Director of Finance stating the work
59 accomplished and the services provided and the costs of
60 accomplishing the work and providing the services, citing
61 meaningful measures of program effectiveness and costs, as is
62 required for state agencies in Code of Alabama 1975, Section
63 41-19-11.

64 (d) The Director of Finance shall forward a copy of all
65 required reports to the Legislative Council in a timely
66 manner.

67 Section 4. This act shall become effective October 1, 2026.
