4	SYNOPSIS:
5	Under existing law, a court is required to
6	suspend the driver license of a person convicted of
7	eluding or attempting to elude a law enforcement
8	officer.
9	This bill would provide that a court must
10	sentence a person convicted of eluding or attempting to
11	elude a law enforcement officer to a minimum of 60 days
12	confinement.
13	This bill would also provide that a person
14	arrested for eluding or attempting to elude a law
15	enforcement officer shall not be released from jail
16	under bond or otherwise for at least 48 hours.

57	(d) Upon conviction of subsection (a) or (b), the court
58	shall do both of the following:
59	(1) Sentence the defendant to a minimum of 60 days

64	(e) It is not a violation of this section for an
65	individual to continue traveling at or below the speed limit,

68	Section 2. An individual charged with a violation of
69	Section 13A-10-52, Code of Alabama 1975, shall be subject to a
70	48-hour temporary holding period from the time of arrest. The
71	individual shall be held in custody and any bond, appearance
72	bond, secured appearance bond, or personal recognizance order
73	shall not be enforced nor executed, and the individual shall
74	not be released on bail or otherwise, until the passage of the
75	48-hour temporary holding period from the time of the arrest
76	has been completed.
