30 PROPOSED AMENDMENT

- 31 (a) No crime shall be punishable by death, and the
 32 Legislature, by general law, shall prohibit the death penalty
 33 for the commission of any crime.
- 34 (b) Any general law authorizing any individual to be 35 punished by death shall be deemed void.

36 Upon ratification of this constitutional amendment, the 37 Code Commissioner shall number and place this amendment as appropriate in the constitution omitting this instructional 38 39 paragraph and may make the following nonsubstantive revisions: change capitalization, hierarchy, spelling, and punctuation 40 41 for purposes of style and uniformity; correct manifest 42 grammatical, clerical, and typographical errors; revise 43 internal or external citations and cross-references; harmonize language; and translate effective dates. 44

END OF PROPOSED AMENDMENT

Section 2. An election upon the proposed amendment shall be held at the statewide primary election in 2028 in accordance with Sections 284 and 285 of the Constitution of Alabama of 2022, and the election laws of this state. The appropriate election official shall assign a ballot number for the proposed constitutional amendment on the election ballot and shall set forth the following description of the substance or subject matter of the proposed constitutional amendment:

"Proposing an amendment to the Constitution of Alabama of 2022, to abolish the death penalty.
