SYNOPSIS:

This bill would propose an amendment to the Constitution of Alabama of 2022, relating to Tuscaloosa County, to authorize the full-time mayors of municipalities in the county to participate in the Employees' Retirement System of Alabama under the same terms and conditions as other employees in the same retirement system.

To propose an amendment to the Constitution of Alabama of 2022, relating to Tuscaloosa County, to authorize the mayors of municipalities in the county to participate in the Employees' Retirement System of Alabama under the same terms and conditions as other employees in the same retirement system.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The following amendment to the Constitution of Alabama of 2022, is proposed:

PROPOSED AMENDMENT

In Tuscaloosa County, full-time mayors of

municipalities in the county may participate in the Employees' Retirement System of Alabama under the same terms and conditions as other employees in the same retirement system. Any mayor holding office at the time of the ratification of this amendment shall be eligible to purchase service credit in the Employees' Retirement System for the time the official has served in the current office. No individual may participate in both a supernumerary program and the Employees' Retirement System based on the same service.

Upon ratification of this constitutional amendment, the Code Commissioner shall number and place this amendment as appropriate in the constitution omitting this instructional paragraph and may make the following nonsubstantive revisions: change capitalization, hierarchy, spelling, and punctuation for purposes of style and uniformity; correct manifest grammatical, clerical, and typographical errors; revise internal or external citations and cross-references; harmonize language; and translate effective dates.

END PROPOSED AMENDMENT

Section 2. An election upon the proposed amendment shall be held in accordance with Sections 284, 284.01, and 285 of the Constitution of Alabama of 2022, and the election laws of this state. The appropriate election official shall assign a ballot number for the proposed constitutional amendment on the election ballot and shall set forth the following description of the substance or subject matter of the proposed constitutional amendment:

Proposed by Act ____."

This description shall be followed by the following language:

"Yes() No()."

Section 3. The proposed amendment shall become valid as part of the Constitution of Alabama of 2022, when approved by a majority of the qualified electors voting thereon.
