8 WHEREAS, the many fine churches across this State
9 constitute an institutional foundation for an orderly and
10 just society for all Alabamians, and their dedicated service
11 to God and humanity is the bedrock upon which our State and
12 Nation are founded; and

13 WHEREAS, it is appropriate that the members of this
14 legislative body should recognize these venerable religious
15 institutions and their congregations, who, through their
16 unflagging capacity for love, dedication of spirit, and
17 faith in God, strive to enrich the lives of people in their
18 communities; and

19 WHEREAS, one such dynamic and historic community of
20 faith is First Missionary Baptist Church in Huntsville,
21 whose members will celebrate their new sanctuary dedication
22 on January 25, 2026; and

23 WHEREAS, since its founding in 1880, First Missionary
24 Baptist Church (FMBC) has been a faithful witness to God's
25 sustaining presence in Huntsville; born from the vision of
26 Christian families who migrated from Aberdeen, Mississippi,
27 the church first worshiped in a modest home on West Clinton
28 Street under the leadership of Reverend Robert Green; from

29 its beginning, FMBC has been defined by faith, perseverance,
30 and a commitment to worship; and

31 WHEREAS, in 1886, the congregation took a major step
32 forward by constructing its first permanent sanctuary on
33 Steele Street, establishing a sacred space that anchored the
34 church in the community; and

35 WHEREAS, over the decades, under the leadership of
36 devoted pastors, most notably Reverend Dr. Horace P.
37 Snodgrass and Reverend Dr. Julius R. Scruggs, FMBC grew
38 spiritually, educationally, and physically, with its
39 sanctuary serving as the heart of worship, teaching, and
40 fellowship; and

41 WHEREAS, in December 2023, a devastating flood
42 damaged the church sanctuary, but what could have been a
43 setback instead became a moment of renewal; guided by faith
44 and determination, the congregation embraced a complete
45 renovation, transforming the sanctuary into a modern,
46 welcoming worship space; and

47 WHEREAS, today's sanctuary features advanced sound
48 and lighting, enhanced broadcasting capabilities,
49 wide-screen displays, and a flexible pulpit and stage,
50 enabling FMBC to proclaim the Gospel with clarity and
51 relevance for generations come; and

52 WHEREAS, now, under the leadership of Reverend Dr.
53 Carlos D. Williams, FMBC celebrates not only a newly
54 restored sanctuary, but also a renewed vision for ministry
55 that is rooted in worship, strengthened by community, and
56 empowered for the future; and
