7 WHEREAS, Sheriff Matthew Wade has dedicated his life  
8 to public service, beginning in high school when he joined  
9 the Army Reserve; he completed Basic Training at Ft. Sill,  
10 Oklahoma, and later trained as an Aviation Operations  
11 Specialist at Ft. Rucker, Alabama; and

12 WHEREAS, in 1996, he began his law enforcement career  
13 as a correctional officer at the Calhoun County Sheriff's  
14 Office through a Jacksonville State University employment  
15 program; he rose through the ranks as a Deputy Sheriff,  
16 Investigator, Emergency Services Team member, and Chief  
17 Deputy, serving 12 years under Sheriff Larry Amerson; and

18 WHEREAS, Sheriff Wade was appointed Sheriff of  
19 Calhoun County in 2016 following Sheriff Amerson's  
20 retirement, and he is now serving his third term, earning  
21 the trust of Calhoun County residents through his steadfast  
22 leadership and integrity; and

23 WHEREAS, he made history as the first deputy from the  
24 Calhoun County Sheriff's Office to graduate from the FBI  
25 National Academy in Quantico, Virginia, and further  
26 distinguished himself as the first law enforcement executive  
27 in the nation to complete the Department of Homeland
