7 WHEREAS, it is with profound appreciation and deepest  
8 admiration that we recognize Birmingham Police Lieutenant  
9 Rebeca Herrera for more than 20 years of steadfast service  
10 and leadership in various roles within the Birmingham Police  
11 Department; we also take this opportunity to heartily  
12 congratulate her on the momentous occasion of her  
13 retirement, effective January 23, 2026; and

14 WHEREAS, Lieutenant Herrera, who holds a Bachelor of  
15 Science in Criminal Justice from The University of Alabama  
16 at Birmingham, began training at the Birmingham Police  
17 Academy on November 29, 2004; she served as a South Precinct  
18 Officer for two years beginning in April 2005; and

19 WHEREAS, she then worked a variety of assignments,  
20 including as a South Precinct Task Force Officer from 2007  
21 until 2009 and a Vice/Narcotics Unit Detective for six years  
22 beginning in 2009; and

23 WHEREAS, Lieutenant Herrera and her husband, Charles  
24 Newfield, made history in October 2015, when both were  
25 honored in a special ceremony at police headquarters;  
26 surrounded by family, friends, and coworkers, the couple  
27 officially received their sergeant's stripes together; it  
28 was the first time in BPD history that a married couple was

29 promoted at the exact same time to the exact same rank,  
30 according to then-Police Chief A.C. Roper; and

31 WHEREAS, she served as a sergeant, first in the East  
32 Precinct, and then in the Internal Affairs Division, until  
33 July 2019; and

34 WHEREAS, Lieutenant Herrera was promoted to the rank  
35 of Lieutenant in July 2019, and was assigned as the Day  
36 Shift Commander at the North Precinct; she was assigned as  
37 Commander of the Special Victims Unit in January 2021, and  
38 has served as the East Precinct Lieutenant since March 9,  
39 2024; now therefore,
