8 that Mr. Russell Davis is highly congratulated and commended
9 for his dedication in serving as the Executive Vice
10 President of the Home Builders Association of Alabama (HBAA)
11 for the last 41 years; and

25 a past president of the Alabama Council of Association
Executives; he is also certified by the National Association

29 WHEREAS, Mr. Davis chaired the Business Associations' 29
30 Tax Coalition for six years; he also served on the executive 30
31 committee of the Alabama Civil Justice Reform Committee and 31
32 chaired the Alabama Council of Association Self Insurers' 32
33 Funds; and

34 WHEREAS, he was recognized for his outstanding work 34
35 in 2024 when he received the Seldon Hale Career Achievement 35
36 Award from the National Association of Home Builders; this 36
37 award represents the highest level of dedication, loyalty, 37
38 and commitment for executives in the housing industry; and

39 WHEREAS, Mr. Davis officially retired from his 39
40 position as Executive Vice President in December 2025; his 40
41 legacy of service and advocacy has shaped the landscape of 41
42 the housing industry for thousands of builders; now 42
