4 SJR___ ESTABLISHING THE ALABAMA FOREST PRODUCTS RETENTION
5 AND PULP AND PAPER MILL STABILITY STUDY COMMISSION.

7 WHEREAS, the forestry industry is a cornerstone of
8 Alabama's economy, with over 23 million acres of forestland
9 covering roughly 69 percent of the state; and

10 WHEREAS, the forestry industry also generates a total
11 annual economic impact of 36 billion dollars to, and
12 directly supports over 40,000 jobs in, this state; and

13 WHEREAS, Alabama is home to more than 110
14 manufacturing facilities, including critical sawmills and
15 pulp and paper mills, all of which are crucial for rural
16 economies and economic development; and

17 WHEREAS, the pulp and paper sector of the forestry
18 industry is facing evolving market challenges, international
19 competition, and environmental regulatory changes that
20 necessitate a proactive approach to keeping these facilities
21 in Alabama; and

22 WHEREAS, it is in the state's best interest to ensure
23 that pulp and paper mills located in the state remain
24 competitive, well-capitalized, and operational to sustain
25 local economies, forestry jobs, and ancillary service jobs;
26 now therefore,

27 BE IT RESOLVED BY THE LEGISLATURE OF ALABAMA, BOTH
28 HOUSES THEREOF CONCURRING, That the Alabama Forest Products

29 Retention and Pulp and Paper Mill Stability Study Commission
30 is established to study the forestry industry as a whole,
31 with a specific focus on the best practices to retain pulp
32 and paper mills in this state and how best to maintain the
33 state's attractiveness to these sectors.

34 (a) The study commission shall consist of the
35 following members:

36 (1) Each member of the Agriculture and Forestry
37 Committee of the House of Representatives, with the chair of
38 the committee serving as chair of the study commission.

39 (2) One member of the House of Representatives,
40 appointed by the Speaker of the House of Representatives.

41 (3) One member of the Senate, appointed by the
42 Lieutenant Governor.

43 (4) The State Forester, or his or her designee.

44 (5) The Secretary of Commerce, or his or her
45 designee.

46 (6) One member appointed by the Alabama Forestry
47 Association.

48 (7) One member appointed by the Economic Development
49 Partnership of Alabama.

50 (8) One member appointed by Manufacture Alabama.

51 (b) The appointing authorities shall coordinate their
52 appointments to assure the study commission membership is
53 inclusive and reflects the racial, gender, geographic,
54 urban, rural, and economic diversity of the state.

55 (c) The initial meeting of the study commission shall
56 be held at the call of the chair no later than July 1, 2026.

57 The study commission may then meet as necessary to conduct
58 business.

59 (d) The study commission shall assess all of the
60 following matters:

61 (1) Strategies to retain forest products and pulp and
62 paper mills in the state, including methods of encouraging
63 existing pulp and paper mills to maintain and expand their
64 presence in the state.

65 (2) Infrastructure needs of pulp and paper mills in
66 the state, including available resources and energy
67 infrastructure needed for mill operation.

68 (3) Methods by which state environmental, labor, and
69 tax policies may be revised to ensure a pro-growth
70 environment for the pulp and paper sectors.

71 (4) Current transitions in the pulp and paper
72 products market and how the state may attract emerging
73 paper-based technology manufacturing.

74 (e) The study commission shall prepare and submit a
75 comprehensive report of its findings, conclusions, and
76 recommendations for proposed legislation, if any, to the
77 Legislature not later than November 1, 2026, at which point
78 the study commission shall stand dissolved.

79 (f) (1) The legislative members of the study
80 commission shall be entitled to their legislative
81 compensation, per diem, and travel expenses for each day
82 they attend a meeting of the study commission pursuant to
83 Section 49 of the Constitution of Alabama of 2022.

84 (2) The nonlegislative members of the study
85 commission shall serve without compensation but may be
86 reimbursed for necessary expenses in attending meetings of
87 the study commission pursuant to the policies of their
88 respective appointing authority.

89 (g) Pursuant to Section 36-14-17.1, Code of Alabama
90 1975, the study commission shall provide to the Secretary of
91 State a notice of all meetings, the name of each member
92 serving on the study commission, and a copy of the final
93 report and any other documents produced by the study
94 commission throughout its duration.
