8 passing of Mr. John Waller Giles at the age of 71 in
9 Luverne, Alabama, while we also celebrate his compassion,
10 advocacy, and public service that aided many during his
11 lifetime; and

12 WHEREAS, his departure on January 17, 2026, leaves a
13 void in the lives of his loving family, many friends, and
14 the community where he was highly regarded; and

15 WHEREAS, born on September 27, 1954, in Orlando,
16 Florida, John was the second son of William Ollie Giles, Sr.
17 and Mary Ella Waller Giles; and

18 WHEREAS, John was a lifelong resident of Montgomery
19 and Honoraville, Alabama; he graduated from Robert E. Lee
20 High School in Montgomery and joined the family business,
21 Giles Enterprises, Inc., for the first part of his career;
22 he then founded Peaches'n Clean, a carpet-cleaning business
23 still in operation today; and

24 WHEREAS, he also held a variety of public positions;
25 he served as the Small Business Advocate for the State of
26 Alabama and Chief of Existing Business Industry Services
27 under Governor Guy Hunt and served as the Appointment
28 Secretary for Governor Fob James; he then served as

30 role, he developed a voting "report card" for Alabama
31 legislators so constituents would know the voting records of
32 their elected officials; in addition, John became a regular
33 article contributor to *The Alabama Gazette*; he most recently
34 worked for First Citizens Bank of Luverne; and

35 WHEREAS, John's journey of faith led him to convert
36 to the Roman Catholic Church in 2004; he was a staunch
37 advocate of the unborn, serving as President of Choose Life
38 Alabama, which sponsors the Choose Life/Support Adoption
39 license plates in the State of Alabama; and

40 WHEREAS, John was larger than life; he loved laughter
41 and was bold, sharing his faith and time with all who called
42 on him; his family is a testament to the love he had for his
43 Sovereign God; and

44 WHEREAS, in addition to his parents, John was
45 preceded in death by his brother, William Ollie Giles, Jr.;
46 and son, Micah Worthington Giles; his survivors include his
