12 High School in Montgomery and later earned her degree from
13 Alabama State University, laying the educational foundation

17 began her career in Alabama's court system as a Clerk and
18 Stenographer with the Department of Court Management,

23 Division of the Administrative Office of Courts (AOC),
24 serving as an Account Clerk and Purchasing Agent, where her
