
What's the new website address?

How do I find Session Information?

Step 1: Open your browser of choice (Google Chrome, Safari, Firefox, Internet Explorer, etc.) to <u>https://alison.legislature.state.al.us</u>

Step 2: The website will open to the Homepage. Click the "Session Info" square.




Step 3: On the Session Info landing page, CLICK the square of the information you wish to find.







Step 4: The **Bill Tracking List Module** will appear and you will be prompted to **Create** a bill list by typing in the name of the list you are creating and then **CLICKING Continue**. If you have created multiple lists you can **CLICK** the **drop down** and CLICK the box next to the name of the list where you would like to save the bill and **CLICK Save.**





Step 5: Once you have exited the Bill Summary Screen you will be back to the Bill Search table, where you will **CLICK** the **My Bills** tab on the left-hand top corner of the bill table.




