To: The Joint Interim Legislative Committee on the Recompilation of the Constitution
From: Karen Smith
Date: June 30, 2021
Re: Revised Numbering System

Amendment 951 to the Constitution of Alabama of 1901, tasks the Legislative Services Agency with recommending to the Legislature a method of recompiling the constitution, by rearranging, deleting, and consolidating certain provisions, as appropriate. One component of the recompilation includes rearranging the numerous local amendments by county of application.

An unofficial “official” recompilation of the Constitution of Alabama of 1901, was completed in 2005. In that recompilation, counties were arranged alphabetically by name with local amendments pertaining to each county being listed alphabetically, by topic, under the county and any municipal amendments being listed last, alphabetically by the name of the municipality. Each local amendment was then assigned a natural number as a section number. For example, the original table of contents for Baldwin County appeared as follows:

As additional local constitutional amendments were enacted and ratified, placement of those amendments in the 2005 recompilation were problematic. Maintaining an alphabetical natural number numbering system quickly became unrealistic and inconsistent. The only solution, for attempting to maintain a rational section numbering system, has been to assign irrational numbers to the newly ratified amendments as their section numbers. For example, the current 2005 recompilation tables of contents for Baldwin County and Madison County appear as follows:

Going forward, LSA proposes consideration of a section numbering system for the 2022 recompiled constitution that is similar to the system used in Title 45 of the Code of Alabama 1975. In 2004, Act 2004-293, HJR315, 2004 Regular Session, directed the Code Commissioner to adopt and incorporate into the Code of Alabama 1975, all local laws. To complete the task, the Code Commissioner created Title 45, with chapter numbers corresponding alphabetically to the 67 counties in the state, and municipal local laws pertaining to each county placed in a chapter immediately following the applicable county, as demonstrated below. LSA is currently compiling Randolph County, and its municipalities, under Chapters 56 and 56A of the Code of Alabama 1975.

Title 45.

- Chapter 1. Autauga County.
 - Chapter 1A. Autauga County Municipalities.
- Chapter 2. Baldwin County.
 - Chapter 2A. Baldwin County Municipalities.
- Chapter 3. Barbour County.
 - Chapter 3A. Barbour County Municipalities.

For consistency and ease of use, each chapter in Title 45 pertaining to a county has the same 26 articles based on the most common topics for which local legislation is enacted. While the specific local laws enacted for each county are unique to that county, they tend to involve the same general areas of law. Each article may be divided further, by part and subpart as appropriate, to allow for the addition and placement of an unlimited number of newly enacted laws. The 26 foundation articles are as follows:
