216 (b) Notwithstanding any other laws to the contrary, the 217 funds appropriated to the Department of Education by 218 subsection (a) of this section shall not be expended without 219 prior approval of the State Superintendent of Education.

220 Section 4. All funds not expended in the current 221 fiscal year shall not revert but be carried forward for the 222 purpose appropriated.

223 Section 5. This act shall become effective immediately
