1 Enrolled, An Act,

2 Relating to DeKalb County; to amend Section 45-25-60,  
3 Code of Alabama 1975, to further provide for an expense  
4 allowance for the coroner; and to amend Section 45-25-230.01,  
5 Code of Alabama 1975, to further provide for the salary and  
6 expense allowance of the sheriff.

7 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

8 Section 1. Sections 45-25-60 and 45-25-230.01, Code of  
9 Alabama 1975, are amended to read as follows:

10 "§45-25-60

11 ~~(a)~~ The Coroner of DeKalb County shall receive an  
12 expense allowance in the amount of ~~six hundred~~ two thousand  
13 dollars ~~(\$600)~~ (\$2,000) per month. The expense allowance  
14 provided in this section shall be in lieu of any other salary,  
15 allowance, expense allowance, or other compensation provided  
16 for by general or local law and shall commence on June 1,  
17 ~~1997~~2024.

18 ~~(b) The Coroner of DeKalb County shall be entitled to~~  
19 ~~receive an additional expense allowance in the amount of four~~  
20 ~~hundred dollars (\$400) per month to be paid out of the county~~  
21 ~~general fund. This expense allowance shall be in addition to~~  
22 ~~any and all other compensation, salary, and expense allowances~~  
23 ~~provided for by law."~~

24 "§45-25-230.01

25 (a) (1) Commencing June 1, 1993, the Sheriff of DeKalb  
26 County shall be entitled to an additional expense allowance in  
27 the amount of fifteen thousand dollars (\$15,000) per annum,  
28 which shall be in addition to all other expense allowances,

29 compensation, or salary provided by law. This expense  
30 allowance shall be payable in equal monthly installments from  
31 the general fund of the county.

32 (2) Beginning with the expiration of the term of the  
33 incumbent sheriff, the annual salary for the sheriff shall be  
34 increased by fifteen thousand dollars (\$15,000) per annum,  
35 payable in equal monthly installments from the general fund of  
36 the county and at that time subdivision (1) shall become null  
37 and void.

38 (b) (1) Commencing September 1, 2003, the Sheriff of  
39 DeKalb County shall receive an additional expense allowance in  
40 the amount of five thousand dollars (\$5,000) the first year,  
41 ten thousand dollars (\$10,000) the second year, and fifteen  
42 thousand dollars (\$15,000) the third year and thereafter per  
43 annum, which shall be in addition to all other expense  
44 allowances, compensation, or salary provided by law. This  
45 expense allowance shall be payable in equal monthly  
46 installments from the general fund of the county.

47 (2) Beginning with the expiration of the term of the  
48 incumbent sheriff, the annual salary for the sheriff shall be  
49 increased by fifteen thousand dollars (\$15,000) per annum,  
50 payable in equal monthly installments from the general fund of  
51 the county, and at that time, subdivision (1) shall become  
52 null and void.

53 (c) (1) Commencing June 1, 2024, the Sheriff of DeKalb  
54 County shall receive an additional expense allowance in the  
55 amount of twelve thousand dollars (\$12,000) per year, which  
56 shall be in addition to all other expense allowances,

57 compensation, or salary provided by law. This expense  
58 allowance shall be payable in equal monthly installments from  
59 the general fund of the county.

60 (2) Beginning with the expiration of the term of the  
61 incumbent sheriff, the annual salary for the sheriff shall be  
62 increased by twelve thousand dollars (\$12,000) per year,  
63 payable in equal monthly installments from the general fund of  
64 the county, and at that time, subdivision (1) shall become  
65 null and void."

66 Section 2. This act shall become effective on June 1,  
67 2024.
