

9	Relating to Jacksonville State University; to amend
10	Section 16-52-3, Code of Alabama 1975, to increase and revise
11	the at-large membership of the board of trustees to include
12	four at-large members, two of whom reside within this state
13	and two of whom reside outside of this state.
14	BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
15	Section 1. Section 16-52-3 of the Code of Alabama 1975,
16	is amended to read as follows:
17	<b>"</b> §16-52-3
18	(a) There is created a Board of Trustees for
19	Jacksonville State University, the state educational
20	institution formerly known as Jacksonville State College at
21	Jacksonville, Alabama.
22	(b) The board of trustees shall consist of two members
23	from the congressional district in which the institution is
24	located, one from each of the other congressional districts in
25	the state, <u>one</u> two at-large member members from the this
26	state, - one two at-large-member members from members who reside
27	either within or outside of the this state, and the Governor,
28	who shall be ex officio president of the board.





- 29 (c) The trustees shall be appointed by the Governor, by
  30 and with the advice and consent of the Senate and, commencing
  31 on May 26, 2015, shall be appointed to hold office for a term
  32 of six years and until their successors shall be appointed and
  33 qualified. No trustee shall be appointed to serve more than a
  34 total of three full terms.
- 35 (d) No trustee shall receive any pay or emolument other 36 than his or her actual expenses incurred in the discharge of 37 his or her duties as such.
  - (e) A trustee who has attained the age of 75 years during a term of office may continue to serve until the expiration of that term. A trustee who has departed the board and who has attained the age of 70 years or older may be designated by the board as a Trustee Emeritus and may receive such honorary privileges as conferred by the board.
- 44 (f) No employee of Jacksonville State University shall 45 be eligible to serve on its board of trustees."
- Section 2. This act shall become effective immediately.


